between my three Daughters Fanny Massas Malala Savery
Katherine Smith.

Item I also give and devise to my wife Hannah all my
Personal property of every kind to have and to hold &
to dispose of During her life time And at her death all is
to be sold but her Wedding and Cloth the Balance to be
sold by my Executor and the proceeds is to be Equally divided Between

First That my Executor herein after named shall provide

my relations and friends and pay all funeral
expenses together with my just debts herowen and so-
(whereas) I give Out of the Money that my first first
came into his hands as a part or parcel of my Estate

the same and hold it during her life time and at her
death to be sold by my Executor and to be Equally divided

Item I also give and devise to my wife Hannah all my
Personal property of every kind to have and to hold &
to dispose of during her life time And at her death all is
to be sold but her Bedding and Cloth the Balance to be
sold by my Executor and the proceeds is to be Equally divided Between
my three daughter Fanny Massa Mahaly Savery Katherine
Smith

Item I give and devise to my wife Hannah all the money on
hand after my death for her to have and to hold the same
during her natural life time and at her death to be divided

to my Other Three Sons Thomas Smith & James Smith & Garrison
Smith Twenty dollars Each to be paid by my Exeter as the first
and Second Bequeath and under the same Vies

I Give and devise for the Credit of my Sons to have the Money that is
above and the Ballance ^{of the money} to be paid my Exeter to my three —
Daughters Anna Maria Mahaly Spring Katharine Smith
I do hereby constitute and appoint my Trusty friend H. G. Strong
my lawful Exeter to all Intents and Purposes to execute my last
Will and Testament according to the true intent and meaning of
every part and Clause thereof hereby revoking & declarres utterly
void all other Wills & testaments by me heretofore made in Writing —
Whereof I the said Robert Smith do herunto set my hand & seal
this 18th day of August A.D. 1851 Signed Sealed & declared
by the said Robert Smith to be his last Will and Testament
in the presence of us who at his request in his presence made the
presence of each other do subscribe and name as witnesses —

William Smith Ten dollars Each to be paid by My Exeter as
the first bequeath & under the same Views I Give and devise
to my Other Three Sons Thomas Smith & James Smith & Garrison
Smith Twenty dollars Each to be paid by My Exeter as the first
and second Bequeath and under the same Views
I Give and devise for the rest Sons to have the Money that is
aboved ^{and} the Ballance ^{of the money} to be paid my Exeter to my three —
Daughts Fanny Maria Mahaly Spring Katharine Smith
I do hereby constitute and appoint my trusty friend A. G. Strong
my lawful Exeter to all intents and purposes to execute my last
will and testament according to the true intent and meaning of
every part and clause thereof hereby revoking & declares utterly
void all other wills & testaments by me heretofore made in Writing —
Whereof I the said Robert Smith do hereunto set my hand & seal
this 1st day of August A.D. 1850 Signed Sealed & declared
by the said Robert Smith to be his last will and testament
in the presence of us who at his request in his presence had in their
presence of each other do subscribe and name as witnesses —
