

Second: I give and devise to I'rs Rachel Withers, wife of Files Witters and her heirs my tract of land known as the Ephraim Lineberger tr ct owned by my late husband John withers and held by me through inheritance from my son, containing two hundred acres more or less, but the devise does not include about 45 acres of said tract which I have agreed to sell and convey to Jacob Jenkins to be cut off from said tract but the same is excepted from this devise.

Third: I hereby constitute and appoint my friend J. A. Lewis my lawful executor to all intents and purposes to execute this my jast will and test ment according to the true impent and meaning of the same and every part thereof hereby revoking and declaring utterly void all other wills and testaments by me heretofore made.
