Second, That should I die before the majority of my son Earle Stowe Pegram, that my brother J.B.Pegram and my wife Martha R.Pegram take possession of my estate and do and act with it as they think best for my heirs, but if my son Earle Stowe Pegram should reach his majority before my death then he and my brother J.B.Pegram take full and entire possession of my estate and do with it as they think best for my heirs, but at the same time I would wish that they consult with my wife as to her wishes and that her wishes be given full weight.

Third, It is my will as to the division of my estate that it be divided according to the laws of North Carolina, but as to the management of it in the settlement of it, and the disposing of any stocks or lands, it is my wish that it be done by the parties named and in the manner they think best for my heirs.
