Buiness only the house & plantation
I Give the Use & Benefit of to my Beloved

Hoppers to be pd her when the goods & two cows
& pigs

And Eighthly & Lastly I Do Give the Bequeath
to my Beloved wife all the Rest of my personal
-all Estate that is not yet mentioned During
her Life to be by her Divided at her Discretion
to when, Between my two youngest Daughters
Susanah & Anne, &c. Also I Do Appoint my
Beloved son William Moore my whole & sole Executor
of all my Business
