By R. P. Lane to pay over to the estate one hundred dollars for assets to pay off the debts of the estate being that much more than an equal share. And lastly I do nominate and appoint Sarah A. Lane executrix and Wm. G. Lane executor to this my last will and testament.

In testimony whereof I the said George W. Lane have to this my last will and testament, signed sealed and published and declared by the said George W. Lane as and for his last will and testament in the presence of us who at his request and in his presence and in the presence of each other have subscribed our names as witnesses thereto.
