

I Sarah Smith of the County of Greene & State of North Carolina being of sound mind and memory but considering the uncertainty of my earthly existence do make declare this my last will & Testament in manner & form following that is to say

First That my Executor hereinafter named shall provide for my body a decent burial suitable to the wishes of my relations & friends & pay all expenses together with my just & lawfull burials & to whomsoever owing out of the moneys that may first come into his hands as a part & parcel of my estate

I then give and devise to my daughter Rebecca Smith all of my lands that I now own it being one half of the tract where I now live to have and to hold to her the said Rebecca Smith for & during the term of her natural life

I then give & devise to my son William S. Smith all the land I now own it being one half of the tract where I now live except the life estate of daughter Rebecca Smith which I give in a former item of this my will to have & to hold to him and his heirs in fee simple forever

I then give & bequeath to my daughter Rebecca Smith one feather bed & furniture to have & to hold to her & her heirs in fee simple forever

I then give & devise to my daughter Rebecca Smith one feather & furniture to have & to hold to her the said Rebecca Smith for & during the term of her natural life

I then give & devise to my said daughter Sarah Smith & daughter of the said Smith one feather bed & furniture except the life estate of my daughter Rebecca Smith in a former item of this my will to have & to hold to her & her heirs in fee simple forever

I then give & bequeath to my daughter Rebecca Smith eight hundred pounds of Pork or Bacon & all the land on hand twenty five Bunches of Corn eight Bunches of Wheat & all the stock peas & farming implements & to have furniture & all the stock save except one Sow which I give to James Newson son of Salitha Newson I also give my daughter Rebecca Smith all the fodder on hand one cow & calf her choice & all the poultry to have and to hold to her & her heirs in fee simple forever

I then I devise to my daughter Rebecca Smith one Brown horse & mule about three years old to have and to hold to the said Rebecca Smith for & during the term of her natural life

Forward

I then give & devise to my son William S. Smith one Brown horse & mule about three years old except the life estate of my daughter Rebecca Smith devised in a former item of this my will to have and hold to him & his heirs in fee simple forever

I then give & bequeath to Sarah & Smith daughter of Mark Smith one feather bed & furniture one cow & calf to have & to hold to her & her heirs in fee simple forever

I then give & bequeath to James Newson son of Salitha Newson one bed & furniture one young Stear about three years old one Sow to have & to hold to him and his heirs in fee simple forever

I then give to and bequeath to my son Henry Smith one cow & calf to have & to hold to him & his heirs in fee simple forever

I then give & bequeath to my son William S. Smith one cow & calf which he now holds in possession to him & his heirs in fee simple forever

I then give & bequeath to my daughter Rebecca Smith all of my house hold furniture not before disposed of to have and to hold to her & her heirs in fee simple forever

I then give & bequeath the residue of my property as follows to be equally divided between my children to have & to hold to them & their heirs in fee simple forever

And lastly I do here by this will and appoint my trusty friend Jesse Benton my lawful Executor to all intents purposes to execute this my last will & Testament according to the true intent & meaning of the same and every and clause thereof hereby revoking and declaring utterly void all other wills and testaments by me heretofore made
