 of the year of our lords One thousand Eight Hundred and Thirty Seven
 Make and ordain this my last will and Testament in manner and
 form as following to wit 1st I give to my wife Polly a certain
 parcel of Land Beginning at the middle of the Barre running East
 to Donnell's Line thence South to Donnell's line then along
 said line to Henry Hinton line thence north to the big road thence north
 to Ryan line thence along Ryan line to west of the Barre thence East to
 the corner, Also one negro girl named Nick one Gray Horse and Saddle
 one plow and gear then with all the rest of the House Hold and Kitchen
 furniture with the one third of the present crop Corn Wheat & oats hay and
 Saddle Also her Choice of the cows. The following days 1 cow and pigs
 I do give to my son Adam Scott a certain field beginning at a Spring
 New in the line north of the old Barre running East along the line
 to Donnell's line thence north to a gum Donnell Scotts Corner
 thence East along said line including the Road to Rich line
 Creek Creek thence up the tract to the fork thence East

of the gift of our Lord One thousand Eight Hundred and Thirty Seven
Mills and ordains this my last will and Testament in manner and
form as following to wit 1st I give to my wife Polly a certain
parcel of Land beginning at the middle of the Barn running East
to Donnell Scotts line thence South to Donnell Scotts line then along
said line to Nancy Smiths line thence west to the big road thence north
to Hyams line thence along Hyams line to west of the Barn thence East to
the corner, Also one negro girl named Nick one Gray Horse and Saddle
one plow and gear then with all the rest of the House hold and kitchen
furnish with the one third of the present crop Corn Wheat & oats hay and
grass Also her Choice of the cows. The following Aug 1 her and first
2d I give to my son Adam Scott a certain field beginning at a wherry-
tree in the line north of the old Barn running East along the line
to Donnell Scotts line thence north to a gum Donnell Scotts corner
thence East along said line including the Wood to Richs line
Creek Creek thence up the brook to the ford thence South
along said road to the Beginning for which he is to give
his mother the fourth part of the hay yearly to L. Quakers
for her with the use of the Middle Tract

3^d I give to my son Thomas Scott a Certain parcel of Land beginning at the fork of the Creek thence up said creek to Scotts Corners on Ryons Line thence South along said line till east of the Barre thence east through the Barre to ^{North} ~~Donnell~~ ^{Donnell} ~~Scotts~~ ^{Donnell} thence along said line to the petitioners fence named to my son Adams, thence east along said fence to a Cherrytree thence north to the fork of the Creek for which he is to give his mother the fourth of the Hay ten Bushels of Corn and ten Bushels of Wheat yearly during her natural life

4th I also give him my negro Boy Mingo for which he is to buy & hold his mothers four acres

I give to my daughter Polly Donnell one negro Woman named
Charlotte

5th I give to my daughter Abigail Hall one Negro Girl named
Harriette

6th I give to my daughter Daughter Louisa Stealy one negro girl named ~~Charlotte~~ with her offspring

7th I give to my son Adams Scott one negro boy named pink

8th I allow my tract of Land on the High rocks north of Portage and my Waddels tract to be sold

8th I allow my tract of Land on the High rock roads of Gortyace,
and my Maddo tract to be sold

9 I allow all the rest of my lands at the death of my wife to be Equally
divided between my two sons Adam Scott and Thomas Scott

10 The Ballance of my hogs to be divided between Adam Scott and Thomas
Scott also I love Thomas Scott one Cow

11 I Allow my son Thomas the use of my waggons and Smith tools during
his Mothers life by his doing her smithing -

12th I give to my 1st daughter Polly A Horse one Bed and furniture one hammer
one side Godolla and one Cow

13 I also Constitute and appoints my two sons William Scott and John Scott
to Execute this my last Will and Testaments in Whose I have set my hand
and affixed my Seal the day and above written
