I give & lend to my beloved wife Sarah all the Residue of my estate both personal and real including all my Lands & Tenements and other property of every kind and description whatsoever of which I may be Seised and I will and ordain that my Sarah hold and possess the aforesaid Land and premises and other described property for and during the Term of her natural life and at her decease I give and bequeath unto my Son Silman Harris all the lands Tenements and other described property given or lent to my wife during her natural life by him and his heirs freely to be possessed and enjoyed forever and I do by these presents nominate and appoint my said Son Silman Harris and my wife Sarah Sole Executor & Executrix of this my last will and Testament and do further by these presents revoke disannul and disallow all former wills by me in any wise made Ratifying and Confirming this and no other to be my last will and Testament in Testimony whereof I have hereunto

said Land and premises and other described prop-
erty for and during the Term of her natural life
and at her death I give and bequeath unto my
Son Silman Harris all the lands Tenements and
other described property give or lent to my wife during
her natural life by him and his heirs freely to
be possessed and enjoyed forever and I do by these
present's nominate and appoint my said Son Silman
Harris and my wife Sarah. Sole Executor & Executrix
of this my last will and Testament and do
further by these presents revoke disannul and disallow
all former wills by me in any wise made Ratifying
and Confirming this and no other to be my last will

1. Richard Harvorth of Gulfport County and State of North Carolina do hereby make and Ordain this my last will and Testament this 2nd Day of the 12th mo 1837.
2. My will is that all my last Debts and funeral Charges be paid by my Executors
3. I Give and bequeath to my beloved wife one main and Side bedstead one Corn & Cash One Feather bed and furniture all her wearing Apparel to her and her heirs forever also the Clock the Case and Sower with Plate & cutlery to the Key hole the Loom and Tackles the Spinning Spinning the Corners Captains with 12 light fire Tacks Two of the Fatting Hogs and a Pen and Pigs with them Stock Hogs and the two Waggon during her natural life
4. I Give and bequeath unto my Daughter Abigail one feather Bed and furniture and the property she bought at the sale of her Aunt Lams.
5. I Give and bequeath unto my Daughter Martha one feather Bed & furniture and the few things she bought at said Sale
6. I Give and bequeath unto my Daughter Elizabeth one feather bed and furniture and the things she bought at said Sale
7. It is my will that my widow and all my Children have the Plantation whereon I now live for some so long as they live single
8. It is my will that at the death and marriage of all my family that my land be equally divided amongst the Children and the heirs of such as die young
