I Commit my body to the Earth and my Soul to God that Care it and as touching all my Personal & Real Property Which God hath blessed me with In this Life I Give devise & Dispose in the following Form & Manner

1st Item I Will unto my beloved Son Abraham Pufles A part of my Land beginning at a black Oak On or Near the Mill Road running North to the branch thence down said branch to New River, including all my Lands and Improvements lying ^{to the} West of said line, & also Beginning at the Aforesaid black Oak at the Mill Road and running from thence East to me line, the land lying to the South to him & his bodily heirs forever.

Item 2nd After all my Just Debts be fully Paid I Give and Dispose of all the Remainder of my Real & Personal property in the manner & Form following Viz.

3rd Item I Give unto my Aforesaid Son Abraham Pufles One Third part of all my Negroes. One Third part of all my living Stock and also One Third part of all my household Stuff & Furniture.

Item 4th I Give to my Daughter Elizabeth Foster Pufles One Third part of all my negroes. One Third part of all my living Stock, and also One Third part of all my Household Stuff & Furniture.

Item 5th I Give to my Daughter Polly Braswell One Third part of all my Negroes; One Third part of all my living Stock - And also One Third part of all my Household Stuff & Furniture.

Item 6th I Will that my Three Aforesaid Children Viz. My beloved Son Abraham Pufles & my two beloved Daughters Elizabeth Pufles and Polly Braswell Give to the Children the heirs of my Son Edward R Pufles dec^d The sum of Two hundred Dollars.

Item 7th I Will that my Three Aforesaid Children Abraham Pufles Elizabeth Pufles and Polly Braswell Give to the Children the heirs of my Daughter Faithy Perkins dec^d The sum of Two hundred Dollars.

Item 8th I Will that my Land on the Mill Creek or the price thereof be Equally divided Among my three Children Abraham Pufles Elizabeth Foster Pufles Polly Braswell And the heirs of my Son Edward R Pufles & the heirs of my Daughter Faithy Perkins

As make this my Last Will & Testament, Such as all Charities me
formerly made in manner & form following, Viz, I Commit my body
to the Earth and my Soul to God that gave it and as touching all
my personal & Real property which God hath blessed me with in
this Life I Give demise & Dispose in the following form & Manner
1st Item I Will unto my beloved Son Abraham Pufles A part of my

part of all my Negroes. One Third part of all my living Stock and also
One Third part of all my household stuff & Furniture

Item 4th I Give to my Daughter Elizabeth Foster Pufles One Third part
of all my negroes, One Third part of all my living Stock, and also
One Third part of all my Household stuff & Furniture

Item 5th I Give to my Daughter Polly Braswell One Third part of all
my Negroes; One Third part of all my living Stock - And also One
Third part of all my Household stuff & Furniture

Item 6th I Will that my three Aforesaid Children Viz. My beloved
Son Abraham Pufles & my two beloved Daughters Elizabeth, Pufles
and Polly Braswell Give to the Children the heirs of my Son
Edward R Pufles the sum of Two hundred Dollars.

Item 7th I Will that my three Aforesaid Children Abraham Pufles
Elizabeth Pufles and Polly Braswell Give to the Children the heirs
of my Daughter Faithy Perkins the sum of Two hundred Dollars

Item 8th I Will that my Land on the Mill Creek or the price thereof
be Equally divided Among my three Children Abraham Pufles
Elizabeth Foster Pufles Polly Braswell And the heirs of my
Son Edward R Pufles & the heirs of my Daughter Faithy Perkins

Item 9th I Appoint my beloved Son Abraham Pufles and my Son in
Law Blaki W Braswell Executors of this my Last Will & Testament

Revolving all Others and disannulling all Others by me
formally made and it is my Desire that my Executors receive
full Satisfaction for their Trouble & Expence in Selling and
the Said Executors to be clear of any damage that accident-
ually may Arise in Selling the Estate.
