of this Court as the Will of Elizabeth Linagar Dec'd & that the
Transcript of the Record aforesaid of the said Will of the Probate
thereof of the qualification of the Executor Isaac Linagar & of the
issuing to him Letters Testamentary be recorded by the Clerk of
this Court in the Record of Original Wills: And that Letters
Testamentary issue to the said Isaac Linagar the Executor
from this Court to execute the said Will in this State
he qualifying and giving Bond in the Security as required
by the Act of Assembly in such case made & provided.
And therefore Came the said Isaac Linagar on to

open Court & entered into bond with Security according to,
and qualified as Executor of the said Will. And Letters
disclaiming charge issued to him on said Will.
