of North Carolina, being weak of body but of perfect Mind & Memory do
make and Ordain this my Last Will & Testament, by
I give & bequeath to my beloved Wife Maria Watson, one third of my lands, no portion
including the buildings Richard & also One bed & furniture one Little Mare
One Cow her choice & her provisions one year also my Clock & all my ~~House~~
Household & Kitchen furniture, and what is hereafter disposed off, One Third
of the Hops & Hops - all the Money on hand as well as Bills due me &
Wish to go towards the payment of my Bills, and the balance I give
into my Wife.

To my Daughter Wm I give One Hundred Dollars, One bed & furniture, One Cow
One Mare named Pats & also the privilege of living on the plantation
during her single state.

I also give unto my Daughter Mary Stuart One Hundred Dollars
I also give unto my Son Thos. Stuart One Hundred & fifty Dollars -

I also give to my son William thirty Acres of land off of the lower end of the
Marshall tract adjoining the lands he now owns, his share, & the remaining
two thirds of the land at the death of his Mother, then I give my son
Johnston the thirds of the Land held by his Mother, & further give to
my son William One lot & furniture & One Cow. In addition I give
unto my son William all the property remaining except that which
has before been devised. The legacy of Money to my two Daughters
and son Alvaugh say Three Hundred & fifty Dollars, I wish my son
Johnston to pay in twelve Months clear of interest.
Lastly, I appoint & constitute my son Alvaugh and Johnston Watson my
Executors to this my last Will & Testament as becoms my hand and seal
this 8th February 1835.
