



In the Name of God Amen. I John Work of the County of Guilford and State  
of North Carolina, being of sound Mind & Memory do Ordain this Instrument  
of Writing to be my last Will & Testament revoking all others this 5<sup>th</sup> day  
of December 1829.

Item 1<sup>st</sup> I will that my Body be decently buried and all my just debts as  
speedy paid as the nature of my Estate will allow.

Item 2<sup>d</sup> I give to my beloved wife Annadittie Work One Dower House, and  
One saddle mare, Saddle and bridle, Two first Choice Cows & Calves, one  
hay, the Stock of Sheep, The first Choice of Hogs, Two Beds & furniture,  
all the Household & Kitchen furniture and Loom, Two first Choice Hens  
& geese, One Ox, One Muzzock, One hog, The first Choice of Hogs Forty  
barrels of Corn, One fodder house, the blade stacks, all the wheat on hand,  
all the Oats, Cotton, flax, and Wool, Two harrows, all the Land I happen  
Two Chits, all the Nails I have on hand to cover her house, & things left  
for and during her natural life.

Item 3<sup>rd</sup> I give to my Neffew James Egleton & his heirs forever One house  
by the name of Buck, One Saddle, One Ox, One Muzzock, One hog, One  
Pig, One harrow, One pair of geese Twenty Barrels, Corn.

Item 4<sup>th</sup> I give to my beloved Daughter Elizabeth Duvier One Dollar.

Item 5<sup>th</sup> I give to my beloved Daughter Elizion Mayes One Dollar.

Item 6<sup>th</sup> All the property not set apart to any person (I may die possessed  
of) to be sold to the highest bidder and should this exceed the debts  
the surplus to go to my wife Annadittie Work, to be governed in the

same manner as in the first clause of this Will

Item of the I Appoint my beloved wife Anna Maria Worts Executrix of this my last Will & Testament, for witness whereof I have hereunto set my hand & seal the day and year above written

Years, I, Riddley Brazil of the County of Gulgord in the State of North Carolina, Being  
very unwell, but of sound Mind & Memory, do make this my Last Will & Testament  
at the same time utterly revoking all former wills made by me, declaring this  
to be my Last Will & Testament.

1<sup>st</sup> I give and bequeath to Sam Price One Frasher Bed & bolster, one Chick Co. Lin-  
tain, One blue Blanket, one bedsheet.

2<sup>nd</sup> I give and bequeath to Rissy Brazil One large Chest, one Box & hooks, also my  
Clothes, to be equally divided among Between Jane Mary Rissy Brazil & One Piece

3<sup>rd</sup> I give and bequeath to Jacob Brazil one large White Towl, I also give Rissy Brazil  
two white Counterpanes, two under Shuts, and one bed quilt, One smoothing Iron,  
One large Pot, One small Pot, One tub, One black Walnut, bedsteads.

4<sup>th</sup> I give and bequeath to Elijah Brazil three head of hoss, one barrow & two sheep

5<sup>th</sup> I give and bequeath to Cork Brazil and Pleasant Brazil & James Brazil One  
pig Each.

I also give to Elijah Brazils Two Children the plated Cups & saucers

I also give to Elijah Brazil One Dollar on Nathaniel Simpson, One Dollar on  
William Brown Fifty Cents on William Simpson
