 Saffah Gibbons also my Will that she has my Saddle One Wheel
 Table to her and her Property and to my Grandson William Hensley
 have a Little Cow my Will that my Daughter Sophia should have
 my clock also One half Parcel to my Grand Daughter Liddy Joseph
 also my Will that she has my Red shirt and leather shoe and under
 Red Belt and two Pillows One Red Quilt to my son to have
 William Joseph two Shells and to my son-in-law Patrick Gibbons
 two Sallings my Daughter Mary a Corded Counter and one
 One Stuffed Red Quilt and Sophia being Red Quilt the remaining
 One Red Quilt my Grandchildren between them I leave to my Will
 Mary Hensley & Joseph Hensley to my Executors.

In the name of God amen. I Robert Hannah being in a good
 State of Health but of sound mind and memory do hereby declare to God
 On this fourteenth day of July One Thousand Eight Hundred &
 Eighty Nine do make and publish this my Last Will & Testament in
 Manner following that unto my First Son and Heir unto my
 son Robert Hannah ten Dollars together with what he has already
 Received as his full Portion of my Estate Second I Give and Bequeath unto
 my son John Hannah ten Dollars together with what he has already
 Received as his full portion of my Estate. Third I Give and Bequeath to
 my son James Hannah ten Dollars together with what he has already
 Received as his full portion of my Estate. Fourth I Give and Bequeath to
 my son Joseph Hannah ten Dollars together with what he has already
 Received as his full portion of my Estate Fifth I Give and Bequeath
 unto my son Simeon Hannah ten Hundred Dollars and my First
 Second Son Received as his full portion of my Estate. Sixth I Give
 and Bequeath to my son & Heir Hannah ten Dollars together with
 what he has already Received as his full portion of my Estate
 Seventh I Give and Bequeath to my Daughter Mary Galt ten
 Dollars together with what she has already Received as her full
 portion of my Estate. Eighth I Give and Bequeath to my Son son
 Alexander and William my plantation in which there are two
 Gaithers with my Negroes and all farming Utensils to be equally
 divided between them. Also the Stock of Cattle and Hogs to be
 divided between Alexander and William so as to make them equal
 by Gentry Williams as also I Give and Bequeath unto William
 my Reddy Horse the Balance of my Stock to be equally divided
 between Alexander & William. Also I Give & bequeath unto my son Alexander
 Hannah my Negro man Robt. Also I Give & bequeath to my son William my
 Two Negro Boys Isaac & Ned as their full portion of my estate.
 Ninth I give & bequeath to Abby Hannah daughter of my son Robert
 One feather bed & furniture.
 Tenth, I give & bequeath to John Hannahs daughter Melinda
 One do.
 Eleventh, I give & bequeath to Joseph Hannahs daughter Abby one do.
 Twelfth, I give & bequeath to the balance of my Grand daughters named
 Abby twenty five Dollars each.
 Thirteenth, I give & bequeath to my son Joseph son Robert all that tract of land
 in which is father now lives, to be occupied by his father till he becomes of full
