Shall Receive the same again by the mighty power of God that
Gave it me and as Touching herds Wordly Estate wherewith it
hath pleased God to Bless me in this Life, I Give Dominion &
disposse of the same in the Following Manner & forme

I am I Give & bequeath to my Neffew Col. Waller McConnell One Bed
with all its Furniture also One Quicke & Book Case, & his Choice of the Two Tables
Also his Choice of Two head of Cattle out of the Stock also one third part
of all my Dresser Table & Kitchen Furniture, I am I Give & bequeath
to Margerat Stewart, One Bed with all the furniture therunto belonging
Also One third of all my Dresser Table & Kitchen Furniture also all my
Wearing Apparel of Every Kind, I am I Give & bequeath to Adam
Lachey Stewart, One Bed & furniture also at my death if I shall be in
possession of a horse or mare that to be Adam Lachey Stewart but if that
should be neither of either kind the sum of Sixty Dollars in money
Also his Uncle Walnuts Chest also One Cow one 2 Year Old Stur & One
Year Old -- I am I Give to Adam Lachey Stewart, One Third Part
of all my Kitchen Dresser & Furniture -- I am I Give to Adam
Lachey Stewart, One Negro Girl named Gingey Aged Sixteen
Years With all her Issues and all my Books to be Equally divided
Between Waller McConnell Margerat Stewart & Adams Lucy Stewart
I am I Give & bequeath to Gingey Stewart, One Two Year Old Heifer
