Eighth I Give and Bequeath to my son Alexander and William my plantation in which I own two Co. together with my Negroes and all Farming Utensils to be Equally Divided between them. Also the Stock of Cattle and Hogs to be Equally Divided between Alexander and William so as to make them equal by Counting William in also. I Give and Bequeath unto William my Reddy House the Balance of my Stock to be Equally Divided between Alexander & William. Also I Give & bequeath unto my son Alexander Hannan my Negro man Rob. Also I Give & bequeath to my son William my Two Negro Boys Isaac & Ned as their full portion of my estate. Ninth I give & bequeath to Abby Hannan daughter of my son Robert One feather bed & furniture. Tenth, I give & bequeath to John Hannan daughter Melinda One do. Eleventh, I give & bequeath to Joseph Hannan daughter Abby one do. Twelfth, I give & bequeath to the balance of my Grand daughter named Abby twenty five Dollars cash. Thirteenth, I give & bequeath to my son Joseph son Robert all that tract of land

And I hereby make & ordain my worthy friends James Hanner & John Landreth Executors of this my last will & Testament in witness whereof I the said Robert Hanner have to this my last will & Testament set my hand & seal the day & year above written
