No man can retain this as my Last Will & Testament in manner & form as
follows. First. It is my will that all my just Debts be paid.

already deeded to him also a Negro boy named Ransom, together with
all the other property that I have given to him already.

Thirdly. I Give and bequeath to my son Robert Hanner all the property
which I have given to him including a tract of land deeded to him
by Robert Hanner & also a Negro boy named Isaac.

Fourthly. I Give and bequeath to my son Elio Hanner all the land which
I have hitherto deeded to him together with all the other property already
given him.

Fifthly. I do hereby constitute and appoint my worthy friends Roger
Hudman, Alexander Hanner and my son John Hanner Trustee & Guardian
for my son Lewis Hanner and upon the death removal or Removal
of any one of them, the other two shall appoint or fill up the Vacancy
by appointing another to whose Care and Management I leave the
following property for the benefit and support of my said son Lewis
Hanner aforesaid and they are hereby directed to act in all things
respecting this trust either directionary or legally as they may determine
it best for him the property as follows all the land whereon I now
live and one Negro woman named Pitt the two pieces of the Gun one
Barshair plough, One Shovel plough, One bill Tongue plough, One set
of Harnes horse One Ax, One Sow bridge, Two Chivies, One set of double
Tres, Two beds & furniture, The Cupboard & furniture, Two Walnut Chests,
One Walnut Table, Four Chairs, Two Cows & Calves, One heifer, The Bounce
Mare & Bedford Horse, and the Cooking Utencials that belong to the
House & Kitchen, six Head of Hogs, Three Chivies, and Two Sheep, all of which
property the aforesaid Guardians are to Manage for his benefit and if
he should leave any legal heirs they or their successors are to deliver
over to them at his death, or if by the said Lewis Hanner should die
without any legal representatives as heirs the property or the income
that may be left after supporting him is to be sold by them and
equally divided to said heirs if such if none then they are to divide

No make and Ordain this as my last Will & Testament in

Barsham plough One Shovel plough One Bells Tongue plough, One set
of Harnes hoes One set, One Iron wedge, Two Clivices, One set of double
Fers, Two beds & furniture, The Cupboard & furniture, Two Walnut Chests,
One Walnut Table, Four Chairs, Two Cows & Calves, One heifer, the Bounce
Man & Redford Horse, and the Cooking Utencils that belong to the
House & Kitchen, six Head of Hogs. These Choicks, and Two Sheep, all of which
property the aforesaid Guardians are to Manage for his benefit and
he should have any legal heirs they or their successors are to deliver
over to him at his death, or if the said Edwin Hanmer should die
without any legal representatives as his the property or the income
that may be left after supporting him is to be sold by them and
equally divided to said heirs if such if none then they are to divide
the same among my four Children, to wit John Hanmer, Robert Hanmer
Eli Hanmer & Abby Field, or if any of them should die the children
of the deceased to have receive the part that their Father or Mother would

be intituled to Shaw and Shaw altho.

Firstly of you and bequeath to my Daughter Abby Field all the property I have heretofore owned her including a Negro Girl Painter dealer and a Negro woman named Rachel it is my Will & desire that the Balance of my Negros be sold. lowest, Aug. George, Abby & Martin & the Amount of the sale to be divided as follows Eli Hanna is to have One hundred Dollars first, and the balance of said sale to be Equally divided between my sons John Robert & Eli Hanna my Will and desire is that Ruddy Hanna son of John have Ten Dollars and Noah Hanna son of Robert have Ten Dollars and that Ruddy Field son of my daughter Abby have ten Dollars in Cash out of my Estate, and that my Grand daughter Sally Field have my bed & furniture, and that my Grand daughter Sally Pauline Hanna have Ten Dollars in Cash, and that Roberts daughter Sally have the bed & furniture I bought at Eli Hanna's sale.

The Balance of my Estate property not mentioned in this Will is to be sold and Abby Field to have Twenty five Dollars and Edwin Hanna to have Twenty Dollars the balance to be Equally divided between John Robert & Eli Hanna my two

Daughters I much nominate and appoint my son John Hanna & Paul Coble Executors of this my last Will & Testament - Revoking disannulling all other Will or Wills heretofore by me made Confirming this and this only to be my last Will & Testament In testimony whereof I have caused to set my hand & seal this 4th day of August A.D. 1829

My Will and desire is that Roddy Hanna son of John have Ten
Dollars and Noah Hanna son of Robert have Ten Dollars and
that Roddy Sudds son of my daughter Abby have Ten Dollars in
Cash out of my Estate, and that my Grand daughter Sally Field
have my bed & furniture, and that my Grand daughter Sally
Pauline Hanna have Ten Dollars in Cash, and that Robert's daughter
Sally have the bed & furniture I bought at Eli Hanna's sale.

The Balance of my Estate property not mentioned in this Will is to
be sold and Abby Field to have Twenty five Dollars and Gavin
Hanna to have Twenty Dollars the balance to be Equally divided
between John Robert & Eli Hanna, my sons
