do leave the following as my last Will & Testament Viz. and first I bequeath  
my Will that all my Just Ditts be paid & discharged in due time by my  
hereafter named Executors.

1<sup>st</sup>ly. I give unto my Beloved Wife Judith Russell all the Household stuff  
that she brought into my house that is now remaining I also give her  
the use & profit of the whole of my Estate both Real & Personal while she  
remains the widow of my body.

2<sup>nd</sup>ly. I give unto my Daughter Sarah Russell at the marriage or death of my  
Wife my Southmost house with the Desk & Book Case. One half of the  
household furniture Except a Walnut Table — I give to my Daughter  
Miriam Swain, the Other half of the Household furniture at the time  
before mentioned I give to my Daughter Hephzibah Harbuck.

3<sup>rd</sup>ly. I Give unto my Daughter Mary Lynde One Tract of

5<sup>th</sup> I Give unto my Son William Russell Ten Shillings.

6<sup>th</sup> I Give unto my Son George Russell Ten Shillings.

7<sup>th</sup> I Give unto my Son in Law Paul Swain & his Wife Mariam One  
half of the Tract of Land I now live on the Other half of said  
Tract of Land I Give unto my Daughter Sarah Russell & said  
Land to be Equally divided between them.

Which I Give to them said Paul Swain & his wife Mariam & Sarah  
Russell to them & their several heirs & assigns forever. (Provided  
they have the Care and Support of my Son David Russell

(with his industry) for and during his natural life  
 8<sup>th</sup> And that all the Stock & Farming Utensils on the above I<sup>a</sup>  
 Premises be at the disposal of said Rud Swain & his  
 Wife Meriam and Sarah Russell at the time above  
 mentioned.

And Lastly I Constitute & Appoint my Son in Law Rud Swain  
 & my Daughter Sarah Russell Joint Executors of this my  
 last Will & Testament - In Witness Whereof I have hereunto  
 Set my hand & Seal This Twelfth day of the Second month  
 in the Year of our Lord One Thousand Eight Hundred &  
 Eighteen.
