use and benefit of my dwelling House and a sufficient and plentiful support of my plantation and One horse beait and One Mule Cor all during her life term or widowhood, and at her death all my stock is to go to my son Isaac Armfield with the Horse beait and Cor that my wife may have

I Give and bequeath unto my daughters namely Jane Armfield Purchase Mary Mary Eliza Sarah Mable and Elizabeth each one is is each.

I Give and bequeath unto my son Jacob Armfield ten Dollars also

I Give and bequeath unto my son Wm Armfield Ten Dollars

I Give unto my son Robert Armfield all the land I am in possession of and all my farming tools besides I also give and bequeath unto my son Robert Armfield all of the Balance of my property of every kind for his own use and benefit to have and to hold as his own forever

I do also Give and bequeath unto my son Isaac Armfield a fifty five Dollars to be divided amongst his Children as follows

It is my will that his son Leab Armfield is to have fifty dollars of it and the other five Dollars is to be equally divided between his son Robert Armfield and his Three Daughters namely Mabelda Edwards Veluvious Edwards and Eliza Daugherty all to be paid out of my Estate I do also give and bequeath unto my Grandson William Nelson Armfield forty five Dollars to be paid out of my Estate I hereby nominate

I do also give and bequeath unto my son Isaac Armfield a fifty five dollars to be divided amongst his children as follows

It is my will that his son John Armfield is to have fifty dollars of it and the other five dollars is to be equally divided between his son Robert Armfield and his three daughters namely Hannah Edwards Valerious Edwards and Elmer

I do also give and bequeath unto my Grandson William Nelson Armfield forty five dollars to be paid out of my Estate I hereby nominate an appoint my son Robert Armfield and John Edwards my whole and sole executor for this my last will and Testament discharging and revoking all other wills by me heretofore made Ratifying and Confirming
