and one Fetter Bed and ofre you I tēm
I Give and Begueth to my son John Enry Ninety Acres
of Land situate in the remaining Part of the hundred and
Eighty acres before mentioned land all on the lower
Side of the Ape said Branch called the Lower branch
and so running from the Head of the said branch to
Cactus Linc I likewise Give my said son John Enry
one Cow and Calf aged one Fetter Bed item I Give and
Begueth to my Daughter Mary Enry one Cow and
Calf item I Give and Begueth to my Daughter Elizabeth
One Cow and Calf item I Give and Begueth to

My Daughter Lucy Emory one Cow and Calf Ilem I Give
and Bequeath to my Daughter Lucy Emory one Cow &
Calf Ilem I give and Bequeath to my Daughter
Martha Emory One cow and Calf Ilem I Give and
Bequeath to my son Edmund Emory one Cow and
Calf and One Ileather Bed Ilem I send to my well
Beloved wife Sarah Emory all the Rest of my My Most
esteemed Estate in General with the Plantation whereon
I now live during her widowhood and if she
Never Marry again after my decease surviving her Natural
Life and after her decease the said Sarah and
Plantation to Return to my above mentioned son Edmund
Emory and all the Moreable Estate to be Equally
divided among all my natural Children and to
constitute and appoint my well beloved wife Sarah Emory
here and sole Executrix of this my Last Will and Testament
and I do here by Revoke All former Wills and make void
all former Wills by me before made or spoken
in Writing whereof I have written set my Hand and
affixed my Seal this 14th day of May 1763 e.
