

John Vincent's will

In The Name of God Amen. I John Vincent of  
the County of Halifax State of North Carolina being very sick but in my  
perfect mind & Senses, but calling to mind the Mortality of man. That it is appre-  
for them once to die. I first recommend my body to the dust and my Soul unto  
God who Gave it. hoping & Trusting in the morning of the resurrection  
that he will bless both Body & Soul & for my Worthy Goods. that it has pleased  
The almighty to bless me with. I desire that all my just debts be paid and the  
residue of my Estate. I desire to leave it in the following Manner. To wit  
I give unto my beloved wife Sophia Vincent one Negroe man by the name  
of Tony one Feather Bed & furniture one Trunk three Cows & Calves three  
Sheep & Twenty five Goats one Javel Horse one Cupboard two Sheep Pounds  
I give & bequeath unto my Four Children. to my son Warren Mary Ribona  
Nancy. Four Negroes to wit. William Daniel David & Jacob and the increase  
of either to be Equally divided between them. When my Son Warren  
comes of age.

Item I give & bequeath unto my Son Warren my  
Land lying on Rocky Swamp a tract formerly Rogers containing  
1000 acres bounded by the same more or less. Item I demand

one hundred & twenty five. be the same more or less. Item I command  
My beloved wife my home plantation during her natural life and after her  
Death my desire is that the plantation ~~&~~ Sand be sold & equally divided  
Among my four Children. Item I give unto four Children the residue  
of my Property to be sold next fall and Equally divided amongst them except  
the Crop that will be made this year my desire is that there be enough of  
the Corn raised up at the discretion of three Freeholders to Support my Family  
one year in bread & butter my wife twenty five Shroats for the use of her &  
my Family the ensuing year and the residue of my Crop to be sold & Equally  
Divided amongst my four Children. Item Desire that all my Negroes be kept  
on my home plantation at the discretion of my wife to Support my Children  
During my Wifes widow hood or care she should marry before my Son reaches  
Comer of age my desire is that the Guardian of my Children Should take  
the Children Negroes and hire them out until my Son reaches Comer of age  
Item I further leave my Friends Atticus Davis & my beloved wife  
Executor of my last Will & Testament and at last I leave & empower

the Nineteenth Day of January one Thousand Seven hundred & Ninety Eight

Mind & memory do make & ordain this my last Will & Testament in manner
