daughter Elizabeth Carrick one negro fellow called Bob. Also one bay horse  
called Buck and if my daughter should depart this life without her law-  
fully begetting of her Body my will is that negro fellow Bob & horse  
before mentioned should return to my daughter Anne Daniel to her & her heirs for  
ever — Item I give unto my beloved daughter Sally Cox one bed & furniture  
to her and her heirs forever — Item I give unto my daughter Priscilla Hale  
one Bed Furniture one sorrel horse called Bimby to her and her heirs for  
ever — Item I give unto my beloved daughter Anne Daniel the following negroes  
to work, Tim, Elsey, Incymer, Phoeb, Miriam, Tom, Pukman, Connor, Lotta, Polly, Peg  
& her during her natural life and my will is that after my before  
mentioned Anne Daniels death that the above named negroes, Tim, Elsey, Incymer  
Phoeb, Miriam, Tom, Pukman, Connor, Lotta, Polly, Peg shall go to my Grand  
children hereafter named that is to say and my will and desire is that my  
grand daughter Sarah Brown Long shall have one negro Girl named Connie  
and one negro Girl named Lotta and if my grand daughter dies without any  
fair lawfully begetting of her Body that then the two named negro

I will leave unto my son or her Body male than the forenamed Negro Gennie & also  
to return to her surviving Brothers and their heirs forever also my will &  
desire is that my Grandson Joseph John Daniel shall have a negro man named  
Tim, one negro woman named Amyina to him & his heirs forever and also  
that Polly Daniel shall have two negroes Eliza & Merton to her and her heirs  
forever also that Robert Brinkley Daniel shall have two negroes to wit Tom and  
Rhoda, to him and his heirs forever and also that William Henry Daniel shall  
have one negro boy named Robinson to him and his heirs forever and also that  
Sarah Daniel shall have one negro named Poll to him & his heirs forever; and also  
my will & desire is that my Granddaughter Elizabeth Gott shall have one negro girl  
named Puss after the death of my daughter Anne Daniel to her and her heirs for  
ever — Then I give unto my Grandson William Brinkley the son of Robert Brinkley  
dece<sup>d</sup> one negro man named Job and one feather bed to him & his heirs forever  
Then I give unto my Granddaughter Salley Brinkley the daughter of Robert Brinkley  
dece<sup>d</sup> one feather bed to her and her heirs forever — Then I give and bequeath  
unto my beloved daughter Anne Daniel all the rest of my Estate that is not all  
ready mentioned of every sort and kind and of all things that is to me belong  
ing of my household & Kitchen furniture and furnishable Estate of all kinds hogs, horses  
cattle & so forth to her and her heirs forever — Then I give unto my daughter Polly  
Gott one Bed & furniture to her and her heirs forever — Then I constitute and appoint  
my well beloved friends Archibald Daniel and Lewis Daniel & he shall my Executors  
of this my last will & Testament In witness whereof I have hereunto set my hand  
and signed my seal this the twenty fifth day of June in the year of our Lord 1799.

two posts, one dish, one Basin, 5 plates, one flat iron, six barrels corn, four hundred weight of  
Pork, one running wheel Hards, to her during her Lifetime the ballance of my Estate  
after all debts are paid to be equally divided between my two sons David & Burgess to  
them & their heirs forever, I hereby Appoint my Sons David & Burgess Executors to this  
my last Will & Testament, I leave to Charlotte Hall one Shilling, Henry Hall one Shilling  
Matthew Hall one Shilling, In witness whereof I have hereunto set my hand & seal this  
11th day of September 1799 —
