Item I give & bequeath to my Son Benj<sup>a</sup> Miles one feather Bed & Furniture to him his heirs and assigns forever Item I give & bequeath to my Son Thomas Miles my manor plantation known by the name of Lands containing thereunto of one hundred acres be the same more or less also together one feather Bed & furniture to him his heirs and assigns forever Item my will & desire is that all the residue of my Estate not already mentioned or given to my Two Sons Benjamin & Thomas be equally divided between them Two as being already mentioned & all the rest of my Lawfull children Not alredy named Coequal share & thence alike, I likewise constitute make and ordain my Son Benjamin Miles & my Son Thomas Miles to be my whole & sole Executors of this my last Will & Testament and I do hereby utterly disallow & revoke & disannull all & every other former Testaments & wills by me in any way before named called & bequeathed, Ratifying and Confirming this & no other to be my last Will & Testament. In testifying whereof I have hereunto set my hand & seal this twenty ninth day of July one thousand Seven Hundred & Ninety two  
Signed Sealed published & pronounced by me Tho<sup>s</sup> Miles to be my last will &

Land containing thereunto of one hundred acres be the same more or less, also together one feather bed & furniture  
to him his heirs and assigns forever. Item my will & desire is that all the residue of my  
Estate not already mentioned or given to my Two Sons Benjamin & Thomas, be equally divided  
between them Two as being already mentioned & all the rest of my Landfull children. Not al ready  
named Coequal Share & share alike, I likewise constitute make and ordain my Son Benjamin  
Miles & my Son Thomas Miles to be my whole & sole Executors of this my last will & Testament  
and I do hereby utterly disallow & revoke & disannul all & every other former Testaments & wills  
by me in any way before named written & acknowledged, Ratifying and Confirming this & no other
