Children to have a share here and there and

My stock of cattle hogs and horses and
my tools should be kept on the place with all
the farming tools and a good stable furniture
for the use of my family it is my wish
that my son John Watson and my son
Elihu Watson should act as my Executors
this I leave in the presents of us

 and all my hogs and corn, haggard and harness and
 the plow and the axes & hatchet and tools and every thing

 kettle and every thing that is in the house that are Peter's

William S. Abraham, Consul of the County of Hyattsville
and State of North Carolina, in favor of my last will &
testament, in writing duly executed bearing date February
the 13th 1841. I have given and bequeathed to my beloved
Wife Sarah Anne, all my Lands and Negroes with houses
and a furniture that I do now own in possession of during
her life I have given them to revert to some of my heirs
After the said Abraham, being residents in support
of the said Legatus &c. their power make this power
bearing which I will and intend to be used as a codicil
to my said will and I have as above thereof and I do
hereby revoke the said Legatus by my said will given
to Sarah Anne, my wife, and I do give to each of
my five sons a tract or piece of Land - W. H. Carter
the piece which I now have & Carter in the year of the above
and I do give to each of the five sons the piece of Land
which I have made the said power to them not to sign Legatus
but my wife's death also a small piece of Land to John Carter
my son, during his life and I do give my daughter Mary
Ann Carter and John Carter and John Carter their one share
