

In the Name of God Amen, I John Cabe of the County of Haywood and State of North Carolina, being in perfect health of mind and memory brought by the Course of Nature, I am now Extraordinary, calling unto mind the Weak-ness of my Body and knowing that it is appointed for all men Once to die, do make and declare this my last Will and Testament, that is to say, first and chiefly, I give and recommend my soul into the hands of God that gave it, and my Body I recommend to Earth to be buried in decent Christian burial, at the discretion of my Executors Nothing doing but at the General Resurrection I shall receive the same again by the Power of Almighty God; And as touching such worldly Estate where with it has pleased God to bless me in this life, I give devise and dispose of the same in the following Manner and Form

First, I give and bequeath to Catherine Stiles my Eldest Daughters Child and John Stiles Son of said Stiles, and John Cabe son of my son John Cabe and Joseph Cabe the son of Stephen Cabe deceased, and John Cabe the son of Sam^r Cabe, and John Cabe the son of Zachariah Cabe; To each of them I give the sum of Twenty Dollars to be paid by my Executors to the several mentioned Legatees as the come of Age, if any or either of them should die before the come of Age, that the portion of the Deceased shall be divided among his or her Brothers and Sisters;

Also I give to Amos Cabe an Equal Share of the Estate of what may be left from paying up these above written Legatees, with my own beloved Children each an Equal Share, freely to be possessed and enjoyed; And also the Executors shall give sufficient time to each of the Legatees to come forward and make their Claim known, that Residue may be settled to each of their Satisfaction, And I do hereby utterly, disallow, revoke, disannul and annul every other former Testament Wills, Legacies, bequests and Executors by me in any way before named, written, bequeathed, Ratifying and Confirming this and no other to be my last Will and Testament.
