Freeman, Julia H. Freeman, and James Freeman, all of which I order to the sole use of the above named heirs, after the decease of my beloved wife and that they be not excluded during her life time, and lastly the remainder of the house hold furniture together with sufficient stock to keep up the house and farm, I further order that the remainder of all my property, lands and tenements be sold, and after my just debts is paid, to be equally divided between the heirs of Louisa Freeman & them of Julia Ann Freeman, except five dollars to each of the other three children of my first wife. I further appoint my beloved wife the sole executrix of this my last will and testament, revoking all other wills by me made.
