year of our Lord 1800 make and publish this my last will
and testament in manner following (to wit). . . .
First I give and Bequeath to my Brother John Slade and my
Brother James Madison all my land to be Equally divided
between them both

And I also give and Bequeath to my Sister Susannah Slade
all my Cash in the hands of J^{ts} Jonathan Bell after paying
the Doctors Bill and also my chest and all my furs and
clothes and Everything that I have not already given away
to my Brother above bid & furniture & bedstead to my Sister
Susannah Slade And I hereby make and ordain my
worthy Friend John Gaylord Executor to this my Last
Will and testament, In witnesses whereof I the said Agnes
Slade have to this my Last Will & testament set my hand
and seal this day and bear above written signed sealed
published and Delivered by the said Agnes Slade the
Testator as her Last Will and Testament in presence
of us.

In the Name of God Amen, Malicha Mason of the County of Hyde
Being weak in body but of sound disposing mind and memory
Thanks be to almighty God for it being his mind. The mortality of
my body and knowing that it is appointed for all men to die I
do make certain bequests and appoint this to be my last will
and Testament in manner and form following

First I Leave unto my wife Agnes Mason the house and plantation
with ten acres of Land belonging to it until my Daughter Nancy
Mason arrives to the age of Eighteen years after the expiration
of time is expired then I give the said Land and plantation
unto my Daughter Nancy Mason to her the heirs forever

I Likewise I give unto daughter Nancy Mason one negro Boy
named Daniel and one feather Bed and furniture not belonging
to it and one Linen Wheel and if my Daughter Nancy Mason
should die before marriage or Law full issue then my
will and desire is that my wife possess and inherit all my
that I have given unto her as her own right and property

Secondly I give unto my wife Agnes Mason one negro woman
called Hannah and all the Remainder part of my goods and estate
both within doors and without I give unto my wife Agnes Mason for ever
Lastly I do make certain bequests and appoint my wife Agnes
Mason my whole and sole Executor of this my last will and
testament. In witnesses whereof I have hereunto set my
hand and seal this sixteenth Day of January one thousand
eight hundred & ninety nine 1799
