

In the Name of God Amene, I Calab Hornman bring in a will and a last Condition at this time, this being sound of mind and Memory I do make and ordain this my Last Will and Testament in manner and form following. I leave the use and benefit of the Land and Plantation where I now live on the Plantation where my Mother live take her Choice of either for her Natural Life, If I die and Bequeath to my beloved wife Elizabeth Hornman the following Negroes Jeddiah Castley & mine and the Child that Jeddiah now goes with, with the particular Exception if Jeddiah has any more Children they shall be Equally Divided between my Son James Boner Hornman & Rebecca Hornman the first above mentioned Negroes with the Child that she is now big with to my wife Elizabeth to her and her heirs for ever. If I die and Bequeath to James Boner Hornman Edmon Bina La first above mentioned Negroes to him and his heirs and assigns for ever. If I die and Bequeath to my Daughter Rebecca Hornman the Negro Boy Harry Negro Gil Rod and the Negro Gil Soble to her and her heirs and assigns for ever. If I die and Bequeath to my Son James Boner Hornman all the Land that I own on the North Dunwood Creek and the one half of the Dogwood Survey up Pungo River being the half that lay across the Northward. And I bequeath his heirs for ever. If I die and Bequeath to my Daughter Rebecca Hornman all the Lands that I own where my mother live on the North side of Pungo Creek with the Remaining two hundred and fifty Acres in the Dogwood Survey to her and her heirs for ever. I shall leave my Executors that I shall here after name the power of the Remainder of my Property to settle with the publick officers of this State the treasurer only one year and to pay my Lawfull Debts and the Remainder when done to be Equally Divided between my wife Elizabeth Son James and Daughter Rebecca Hornman. If there is anything coming to me at my mother Death of my Father Estate to be Equally Divided between my son James and Rebecca Hornman my Daughter to them and their heirs for ever. I leave the property of the two Children James and Rebecca Hornman in the power of my wife Elizabeth Hornman if she dies and will Raise them till they come of age.

and she is to give them a good Education without making any charge against them for the same but provided that my Executors that I shall here after mention should conceive that my said wife Elizabeth should not do them third Justice according to their judgment for them to be taken from her and put in the power of James Boner my Brother in Law to bring them up till they come of age. Now I appoint my worthy friend James Boner John Eborn and my Brother Benjamin Hornman my Executors and my beloved wife Elizabeth Hornman my Executive to this my last will and Testament.
