October in the Year one thousand seven hundred and Sixty
Six MDCCLXVI and Publish this my Last Will and Testament in Hennan
and frome following that is to say First I give to my son George
Read One Shillings Sterling its my Will and Desire that John
Fermaw have the Ressal of the land that I Bequeath with
him for and that my Executrix Executive Trustee of the mentioned
Will the said John Fermaw a Deed for the said Land Provided
that the said Fermaw Appies and pay the Money in the Month
of May my Places Outlaye levies and Direct that the said
Land to sold to pay my Debts.

One Shillings Sterling and one half Girl Named
Hannah and all the Rest and Residue of my Estate both Real
and Personal During her Midwchord and then to be Divided Between
My three Children Samuel Lucy and Mary Sheen and their alie
and I make and ordain the my said wife Sole Executrix of this

to this my Last Will and Testament set my hand and seal
