I give and bequeath unto my daughter Elizabeth one
right bow & half after the Decease of my wife (or widowhood,
Intestment. Then I give and bequeath unto my son Joel Swindell
one negro and half of furniture one bow & half after the decease of
my wife or widowhood. Intestment. Then I give unto my
son William Swindell one half of the negro woman Fielet
Excepting the children she should have any hereafter one bow
& furniture one bow & half after the Decease of my wife or her
widowhood. Then I give and bequeath unto my son Miles Swin-
dell one half of all the increase after this of the before mentioned
Fielet one bow & half after the Decease of my wife or widowhood. Then
I give and bequeath unto my two sons Cornelius & Margus Swin-
dell the Plantation whereon I now live to be equally divided between
after the Decease of my wife or her widowhood. Then I leave all
the Rest of my property to my wife after my first debts is paid
And Lastly I do make & constitute and by this instrument
appoint my beloved wife Dorcas Swindell my sole and sole
Executor of this my Last will. Revoking all others by or for
me made Resolving this to be my Last will and testament
whereof I have hereunto set my hand and seal this 16th Day
of August 1814 -
