I commit my soul to The Almighty God who gave it and my
body to be decently interred after the usual form &c. And I
give unto my daughter Sally Jasper six Munro chairs (large trunk
and one small one, one black China bowl six dinner set China cups
and saucers 2 glass candle sticks, I give unto my grand daughter
Ann Jasper one bed and bedstead sheet and bed quilt 1 small
shot glass half dozen of silver table spoons and one large white
metal spoon, I give unto my grand daughter Mary Jasper
one two year old horse if she should live, I give unto my grand
son William Smith one Bedstead and cover bed cover 6 silver table
spoons and ladle, one dining table one dish one looking glass
I send unto my daughter Patience one large China bowl &
punch glass 6 China cups and saucers nine silver tea spoons
nine cushion bottom chairs three flag do one large wheel one
linen doth one hand mill one large iron pot, iron kettle
and do tin kettle one pair fire do pot one pot soup do pot hock
and kitchen furniture & this willd property to become my daughter
Patience's child down after her decease, likewise I send my
daughter Patience all my remaining property not mentioned
here to for to become her children's after her decease 12th Oct. 1814.

In the Name of God Amen I Dinah Jordan of the State of North Carolina
being of sound perfect mind and memory blessed be God do this
11th November in the year of our Lord 1814 make and publish this my
last will and testament in manner following that is to say I give and
bequeath to my son Thomas Jordan all the corn that I have at my death to
him and his heirs forever, I give and bequeath to my son Abraham Jordan
one six pence and my daughter Sarah Tyson one six pence and to my
daughter Betsey Sadler one six pence to them and their heirs forever.
I then give to my son Jack Jordan one six pence I give and bequeath to my
grand son Jack Jordan the horse of Robert Jordan one cow and calf and
my large do trunk to him and his heirs forever. I then I give bequeath
to my son Robert Jordan all the remainder of my estate cattle sheep
hogs kitchen household furniture farming tools and all the residue of
my estate to him and his heirs forever. In witness I have set my hand
and affixed my seal the day and year above written.
