 of my Executors hereafter named, and as Touching my worldly Estate that
 God hath been pleased to Bless me with I Dispose of in manner &
 form following that is to say First I Give and Bequeath to
 Eleanor Jackson one two year old mare to be delivered to him at my decease
 I Give unto Phillip Adams one three year old cow and calf to be put to his use at my
 Decease As for the Rest of my Estate it is my Will & Desire that Thomas
 Adams should have it all and Lastly I do make constitute and or-
 dain my Truly and beloved friend Isaac Jackson to be my
 Executors of this my Last Will & Testament hereby Revoking and making
 void and null all former and other Wills by me here before made or
 declared Either by word or writing and that only and no other to be taken as
 my Last Will and Testament, in testimony whereof I have hereunto set
 my hand and affixed my Seal this fourth
 Day of May 1774

 1774
