In the Name of God Amen this 24th Day of December in the
Year of our Lord 1790. Hugh Henry living on
Maltansket in the County of Hyde being of a sound &
disposing mind & memory thanks be given to the Almighty
God for it and calling to mind the Mortality of my Body
& knowing that it is appointed for all Men once to Die
do make & ordain this my last Will and Testament that
I do say in manner & form as followeth Revoking and
Disannulling by this presents all and every Testament or
Testament Will or Wills heretofore by me made or declared either
by word or Writing and this is to be taken only for my last
Will and Testament & no other and now for the settling
my temporal Estate Goods Chattels & Debts as it
as it hath pleased God to bestow on me I do order give &
Dispose of the same in the following manner & form
I will that all those Debts I justly owe to any person to be truly
paid by my Executors hereafter named—

Item I give to my eldest Son John Henry fifty Acres of Land
where I now live and one Acre or thereabouts

Item I give and Bequeath to my Son Robt. Henry the
other part of fifty acres of Land joining his (and his wife's)
Brother John Bellows and one Feather Bed

Item I give and Bequeath to my Daughter Elizabeth Hopkins ^(Wife)
and ^{to} her and Bequeath to my all the rest of my Estate in Duress
to my wife during her Life and then to be divided among my
other three Children, viz, Margaret, Samuel & Phoebe to be
divided by my Executors and as for my Daughter Elizabeth
Hoskey she hath had her full Share of my Living
Likewise appoint my two sons John & Robert Henry the
Sole Executors of this my last Will and Testament
and I do hereby Disannul every former Testament by me
made willing & Bequeathing & Confirming this and no
other to be my last Will & Testament—

by the said Hugh Henry for my last Will & Testament
