

In the name of God Amen, I Isaac Wilkinson of the County of Hyde &c. bethought myself the uncertainty of Life &c. Do make this my Last will and testament as followeth. I Give unto my beloved wife Mary Wilkinson the Plantation whereon I now live also my Plantation on Parlage above During her natural life & widowhood, I Give unto my said wife one negro boy named George also one negro woman named Jude, also I Give unto my said wife one bed & furniture second. I Give unto my daughter Mary Wilkinson one half of a negro man named Simon also I Give her one negro girl named Kate, also two cows & calves. Third I Give unto my son Israel Wilkinson all my land in Jacks creek Excepting one hundred acres, and also one hundred acres joining Jonathan Jurgensons Line & Mohuns Line &c. to him and the Lawfull heir of his body forever I Give unto my son Isaac Wilkinson my old Plantation up Parlage containing 250 acres also one hundred acres Lying on Jacks creek joining Elons Line &c. to him & the Lawfull heir of his body forever, and if Dying without heir I Give the same to my son Israel Wilkinson and the Lawfull heir of his body forever. — All the Residue of my Land I Give unto my three Daughters to wit Sarah, Elizabeth and Jane Wilkinson to them and their heirs forever I Give unto my Daughter Sarah Wilkinson one negro boy named Anthony and to the Lawfull heir of his body forever. — I Give unto my wife Mary Wilkinson all the Residue of my personal Estate meaning my negroes stock household goods &c. During her Widowhood or until my Children arrive to the age that the Law gives them Liberty to Receive their Property then to be Equally Divided between my said wife and all her own Children forever. I Leave my said wife and my son Israel Wilkinson Guardians to my son Isaac Wilkinson if any should be Requested Lastly I appoint my wife Mary Wilkinson and her Brother Rev. Windley Esquire & Executor to this my Last Will and testament. in testimony whereof I have hereunto set my hand & seal This 11th Day of November 1812

In the name of God Amen I Benjamin Coney of the County of Hyde & State of North Carolina being of sound and disposing mind and memory first shewing that it is appointed for me once to Die, do make this my last will and testament first writing and making void all other wills here before made by me or for me making this Instrument of writing and writing to be and contain my Last will & testament, viz. I Impower I Give to my beloved wife Sarah Coney During the time of her widowhood or until my oldest Child shall arrive to the age of twenty one year old or marry, the use of her choice of one of my negro men unusually, and such of my negro women as may share children with their children, as she and my Executor may think proper, also as much of my Land Lying to the Eastward of Wagoning barrell as may be sufficient for her to have tithed by the above Land negro, having a due regard, to raising & supporting the Land to gether with all the stock of horses cattle sheep & pigs furniture of all my household and kitchen furniture & all my Plantations tools and other implements for farming &c. This to be understood that my wife is to keep at home all such of my negroes as may be expensive and also maintain and educate all my children during said Term, and should the above Land property to be insufficient to support my said wife and her family and educate my children as above stated she shall receive as much more of the Income of my Estate as shall be sufficient, amply to support she & her family and educate my children as above, when my wife marries, I request my Executors to sell all my property of every description except my Land —
