In the name of God Amen, I Edmund Elborn of Hyde County N. Carolina do hereby certify & attest, being in a low state of health, but of sound mind, but nevertheless as I am now, do attempt to make this my last will & testament, and resigning my soul to God who gave it to me and my body to the earth from whence it came, of my will and desire is that my just debts be paid out of my finishable property, and that the residue I send to my beloved wife Martha Elborn all that may be left during life or her widowhood of what ever kind or nature it may consist of and in case she the said Martha should marry, then and in that case, I give to her the said Martha her third of all the finishable property there is then remaining to her then his for ever. 2) I give to my son Luther Smith Elborn all my Real Estate in principle or the whole, and in case he the said Luther should die with out issue of his body, then and in that case my wish and will is that my son Paul Elborn inherit the whole then there of and furthermore, that in case both my sons Luther & Paul should die with out issue as above then and in that case I wish and will that Brother Littleton Elborn son of Hardy Elborn should inherit the same to him and his heirs for ever. 3) I give to my son Paul Elborn one negro boy by the name of Moses it being the same negro boy I bought of my sister Manning Elborn to him and his heirs for ever. 4) I give to my youngest daughter Winfield (son of Davis Winfield Deb.) everything

negro man by the name of Moses to him and his heirs for ever. 5) I give to my two sons Luther & Paul all my property of what nature or kind it may be, to be equally divided between them should and able to do so, and if not already given away to them and - here from by and Lastly I do by these presents hereby give, make and make all will or wills or clauses of wills heretofore by me made concerning and appertaining to this my last will and testament as my children, and bequeath my wife Martha Elborn, Benjamin Elborn & David Elborn black, the testimony whereof I have hereunto set my hand and affix my seal this fifth day of May 1809.
