my beloved wife Executrix and Exceutrix of this my Last will and
Testament signed with my hand and Seal with my seal

after her Decease give and Bequeath to Ormond Forman the other 75
acres of Land old patent further I give and Bequeath to Martha
Benjamin Mel & Ormond Forman all my cattle to be Equally divided
among them. The Rest of my Estate at my Mother's Decease
it will that it should be Equally Divided amongst my
Brothers and Sisters here mentioned Caleb Arkhede
Benjamin Martha Mel and Ormond Forman to be Equally
divided amongst them all. I do hereby nominate and
appoint my loving mother Rebecca Forman Executrix
and my Brother Caleb Forman my Executrix to this my
Last Will and Testament In witness where of I have
hereunto set my hand & seal this 3^d Day of October 1779
