I then the Rest and Remainder of my estate after all my just
Debts and Liabilities paid and after the Death of my mother
I have to be equally divided Betwixt all my children
and lastly I nominate and appoint my beloved
Mother Ben Barrow & Henry Tabley William Boyl John
Edmund Executors of this my last will & testament in testimony
whereof I have hereunto set my hand and seal
