John Easter Executor to this my Last will and Testament

Disposing mind and memory do make and ordain This my Last
will and Testament in form following That is to say I give and
recommnd my soul into the hands of Almighty God who gave it
and my body to be Buried in earth at the Discretion of my Execu-
tors and touching such worldly Estate as it hath pleased God to
Bestow me with I will and bequeath in the following manner —
I give to my wife Laura an ah Prince all my Estate Real & Personal
Ther Life or widowhood there to be Equally Divided amongst my
nine Children namely Richard Prince, William Nicholas Prince
Sally Sarah Nancy Antier and Abner — and Lastly I do hereby
constitute and ordain my wife Laura ah Prince Executor and
my Brother Benjamin Prince Executor of This my Last will
and Testament and I do hereby utterly revoke and disannul all
former wills and Testaments by me in any wise made touching
and concerning This my Last will and Testament In
witness whereof I have hereunto set my hand & seal
This 12 day of March 1807
