In the name of God Amen, I William Coffey of State of North Carolina & County of Hyde being of a sound and disposing mind and memory do make hereunto this Instrument of Writing to be my last will and testament that it to say First I give unto the earth my body to be buried in Christian like manner at the Disposal of my Executor and my soul into the hands of my Redeemer knowing that I shall one day be clothed with this body again and as touching such worldly estate as it hath pleased God to bless me with I give in manner following - To wit, I give unto my daughter Harriet Coffey one feather bed & furniture. Then I give unto my son William Coffey one bed and furniture & one chest. Then I give unto my daughter Mary Coffey one bed & furniture & one chest. Then I give unto the heirs of my daughter Lucy Williams one Shilling &c. I give unto my son Joseph Coffey one Shilling. I give unto my daughter Sarah Coffey one Shilling. I give unto my daughter Elizabeth Soder one Shilling. Then I give unto my son William Coffey should he Return one feather bed & furniture should he not Return it is my Request it belong to my four first mentioned Children. Then I give and bequeath after my Lawfull Debts and Personal Charges &c. paid unto my four Children that is to say Harriet William Lucy Elizabeth and Mary Coffey all the Remaining part of my property Real & Personal. - Also here by constitute and appoint my truly friend Benjamin Sandercock my sole & sole Executor of this my Last will and testament First Reading & Enrolling all other wills by me or for me in any wise made &c. whatsoever. In testimony whereof I have hereunto set my hand and seal to this my last will this 15th June 1806 signed Sealed & published this to be the
