 Item I give and bequeath unto my beloved wife Nancy Bomer  
 one feather bed and furniture one pot and one skillett  
 and two pewter plates and one halfe Gallon Bason to be  
 and remaine her property as long as she lives and at  
 her death for to be equally divided amongst my children  
 Item I give all the Remander part of my estate to be Equally  
 divided amongst my four children Tabith Bomer,  
 Elizabeth Bomer, Willey Bomer & Ben. Bomer  
 excepting so much as will pay all my Lawfull debts
