

In the Name of God Amen, I David Darden of Hyde County in the State of North Carolina Being weak in Body but free of mind & able to put my last will and Testament in writing as followeth.

I Give and Bequeath my Nephew Henry Windley all my lands up Long River Called the Elbow should he Die without issue lawfully Begotten my Desire is his sister Elizabeth Windley should have it.

I Leave my Boy to get himself one year and after the one year I Give him to my two Nephews Henry Windley & Elizabeth Windley should they Both Die without issue lawfully Begotten my Desire is he should be free forever.

I Give my best Horse bridle and saddle to his son Despard Sabo & say my son to be hired at public sale.

I Give all my household furniture and stock of every kind to Henry Windley & Elizabeth Windley to be equally Divided between them both I Leave my in the care of David Windley & Thomas Windley untill Henry Windley comes of age.

Lastly I Appoint David Windley & Thomas Windley Executors to this my Last will & Testament & in testimony Whereof I have set my hand and seal this 16th day of March 1776.

In the Name of God Amen I John Darden of the County of Hyde in the State of North Carolina Calling to mind the mortality of my Body being conscious and weak in body but of perfect mind and memory I make this my last will and Testament in full of my mind the mortality of my body and knowing that it is appointed for all men once to die to make and ordain this my last will and Testament that so it may principally and first of all I Give and bequeath my soul into the hands of God that gave it and my body I Bequeath to the earth to be buried in a decent Christian burial at the discretion of my Executors and touching such worldly Estate where with it hath pleased God to bless me in this life I Give devise & dispose of the same in the following manner and form.

I Give the first of all I Desire that all my Just debts should be paid —
I Give into my Daughter Sarah Boyd one negro girl named Betty to her & her heirs for ever also one hundred silver Dollars in full of my Debt Besides what I have already given her —

I Give unto my Daughter Mary Archbold one negro Boy which she has in her possession named Sam to her and her heirs for ever and one hundred silver Dollars in full of my Debt besides what I have already given her —

I Give into my Daughter Bess Gamet one negro girl named Rose to her & her heirs for ever and one hundred silver Dollars in full of my Debt besides what I have already given her —

I Give into my son Roger Barron all the Land I possess except the west end of my Plantation as far as the Division fence to him & his heirs for ever also one negro fellow named Dick one D^r named Sutter one boy named Murrett and Sallon wench named Dine one negro girl named Rachel to him and his heirs for ever also all my wearing apparel one horse saddle & Bridle horse known by the name of Herod —

I Give & Bequeath unto my beloved wife Anne Barron the west end of my Plantation as far as the Division fence During her natural life after my said wife's decease I Give the said Land unto my son Roger Barron to him & his heirs for ever also the west end of my Dwelling house as far as the Division unto my said wife During her natural life after her decease to return to my said son Roger —

Item The remainder of negroes not already given away I give my wife and four Daughters namely Elizabeth Maria Alice and Lois Barron, to be Equally Divided Between them which s^d negroes I give to them and their heirs forever

Item All the remainder of my Estate not already given, I give to be Equally divided between wife Ann Barron Betsy Barron Elizabeth Maria Alice Lois Barron meaning my stock of all kind Horse hold & Kitchen furniture also all monies Dues &c

Item I also desire the favor of my two friends William Clark and John Satchwell to make the Division of my Estate

Lastly I do nominate and appoint my beloved wife & my son Betsy Barron Executors & Executors to this my last will and testament in testimony whereof I have hereunto set my hand and seal this 10th day of April 1796
