

Will of Thenny Johnson

May 1st first day 1824, I Thenny Johnson do give to my son John Johnson one skillet;
I do give to my son Barney Johnson one linen wheel.

I do give to my son Jacob Johnson one bed cover.

I do give to my daughter Sarah Johnson one cloak one petticoat one sock two wraps.

I do give to my daughter Elizabeth Parrish one bed and cover three plates and two hatchets one apron and two wraps one white apron.

I do give to my son Frederick Johnson one ditch oven one bedstead one basin half dozen earthen plates.

I do give to my daughter Thanny Johnson the ballance of my clothes & wooden vessels.

I give to my son Stephenson Johnson all my hogs and 6 fowls plates and all the best of my property to Stephen Johnson my son and he pay all my just debts.
May the 1st day 1824 I Thenny Johnson do give away all property as she pleases.

Will of Amos Johnston

In the name of God Amen I Amos Johnston of the State of North Carolina and County of Johnston being of sound and perfect mind and memory thanks be given to God for the same and calling to mind the mortality of my body and knowing that it is appointed for all men once to die do make and ordain this instrument to contain my last will and testament in manner and form following (to wit)

I give and recommend my soul into the hands of God who gave it and my body to the earth to be buried in a christian like ^{and decent} manner at the discretion of my executors hereafter named and as touching such worldly estate as it hath been pleased God (to bestow) to bless me with in this life. I give and dispose of in the following manner

I give and bequeath to my son Rubin Johnston all the land that I own on the west side of the mountain branch between the road and middle creek besides what I have heretofore given him to him and his heirs forever

I give and bequeath to my son Britton Johnston one hundred and ten acres of land more or less beginning at a hickory Willie Johnston's corner and runs S 35° W 27 pole to a poplar in the fork of the middle prong of mountain branch thence down the meanders of said branch to the north west prong of said branch then up the meanders of said prong, and Ruben Johnston, Warren Johnston, Dany Johnston and Willie Johnston live to the beginning I also give to my said son Britton one feather bed and furniture to him and his heirs forever.

I give and bequeath to my son Allen Johnston three hundred and fifteen acres of land more or less lying on the stony fork of Hannah creek including the land and plantation where he now lives besides what I have heretofore given him to him and his heirs forever.

I give and bequeath to my son Hardy Johnston all the land and plantation whereon I now live except what I have given to Ruben and Britton containing one hundred and forty more or less also I give to my said son Hardy one feather

bed and furniture one cow and calf one still one rifle gun
one saddle and bridle one axe one iron wedge to him and
his heirs forever.

I give and bequeath to my two daughters Polly and
Lydia all the ballance of my property that I have not given
away to be equally divided between them to them and their
heirs forever.

And lastly I constitute nominate and appoint my beloved
son Reuben Johnston executor to this my last will and testament
disannulling and revoking all other wills and testaments
by me made ratifying and confirming this and no other
to be my last will and testament. In witness whereof I
have hereunto set my hand and affixed my seal this
4th day of March 1824.

Will of Arnold Pugh

In the name of God Amen, I Arnold Pugh of the State
of North Carolina and County of Johnston being in a ~~good~~
state of health but in perfect mind and memory blessed
be God to this 24th day of February in the year of
our Lord one thousand eight hundred and twenty three do
make and publish this my last will and testament in man-
ner following.

I give and bequeath unto Milby Kent the daughter of
Milby Kent wife of Wiley Kent two hundred acres of
land including the plantation whereon I now live to her and
her heirs forever

Also two cows and one yearling one sow and six pigs six
year old hogs one wooden wheel one dutch oven one washing
tub one earthen dish two pewter plates two earthen bowls
one pewter cup five pewter spoon one sitting chair one flatt-
er bedstead and furniture one cutting axe two bee hives
six hundred wt. of bacon one hand saw one drawing knife
two augers one chisel one meal stand one side of leather one
gourd and fat to her and her heirs forever.

I give and bequeath unto Mary Kent daughter of Milby
Kent as aforesaid two hundred acres of land adjoining my
plantation enclosed in the same patent one black horse
saddle and bridle one cow and yearling two heifers one sow
and six pigs one sow and three pigs ten barrels of corn two
bee hives one cutting axe one pot one spider one skillet one
water pail three pewter plates one earthen bowl one coffee
pot one bed bedstead and furniture one chest one gridiron
one pair of sheep shears one sitting chair and one case of
knives and forks one hand mill one side of leather one
grind stone one cart and wheels to her and her heirs forever.

I give and bequeath unto Nathan Crumpler three
hundred acres of land lying on the south side of great
Doutina Creek bounded on the north side by said creek on the
east by William Pugh land on the west by Thomas Eatmans
land to him and his heirs forever.

All the rest and residue of my property I leave to be
sold and the money arising therefrom to be appropriated to
the payment of my debts and if any remaining to be
equally divided between Datince Stickland, Pm Hope Johnston
