

Will of Etheldred Price

In the name of God Amen I Etheldred Price of the County of Johnston and State of North Carolina do make and ordain this my last will and testament in manner following, I give and bequeath unto my beloved wife Lucency Price four hundred acres of land including the plantation wherein I now live her life or intestate then to my son Thomas Price him and his heirs

I give and bequeath to my wife Lucency Price fifty acres of land lying on the east side of Little River during her life or intestate then to my above mentioned to hold ^{him} and his heirs. I give and bequeath to my wife Lucency Price one feather bed, and its necessarys furniture her life intestate then my daughter Nancy Price she and her heirs. I give and bequeath unto my daughter Winifred Price one bed and its necessary furniture and two cows and calves for to hold and enjoy. I give and bequeath unto my daughter Edy Price one bed and furniture for she and her heirs. I give unto my wife twenty four head of cattle for to hold and enjoy. I give and bequeath unto my wife all my household furniture of any kind for her to enjoy she and her heirs. I give and bequeath unto my wife all my corn and bacon that I have in possession at this time for she and her heirs to enjoy. I give and bequeath unto my wife Lucency Price all hogs except fourteen I give to Joel Brian to her to hold and enjoy she and her heirs. I give and bequeath to my wife all my working tools and five head of horses during her life intestate then to be equally divided between the lawful heirs of the estate I give and bequeath to my son Edward Price one sorrel horse by name of Ball and saddle and bridle for him and his heirs. I give and bequeath to Joel Bryan one hundred acres of land being beginning at the mouth of mill Meadow and up courses of the great branch to the old road to Price Prices line and said line to the river for him and his heirs. I give unto Joel Brian one horse named Spark for him to hold and enjoy. I give and bequeath unto my son Edward Price my gun for him and his heirs. I give and bequeath to my son Edward Price four hundred acres of land being on both sides of Cattaraugus and to my back him and down said Cattaraugus to Farm Onals line for him and his heirs. I also give and bequeath to my son Edward Price fifty acres of land lying on the east side of Little River for him and his heirs. I give and bequeath to my daughter Edy Pearce ten shillings. I give and bequeath to my son Thomas Price ten shillings I give and bequeath to my daughter Nancy Price ten shillings

for them and their heirs. I give and bequeath to Joel Brian fourteen head of hogs for him and his heirs. I give and bequeath to my wife eight head of sheep for her to hold and enjoy she and her heirs. I give and bequeath unto Luke Bryan Brian one bed and furniture to her to hold and enjoy she and his heirs. I give and bequeath to my Lucency Price ten pound currency for her to hold and enjoy. I make and ordain my friend Simian Price and Joseph Richardson my executors to this my last will and testament in witness whereof I have hereunto set my hand and seal this the 10th day of April in the year of our Lord 1810.
