- Item I give to my daughter Phoebe Bailey one negro girl named.
- Item I give unto my loving wife Frances one Feather bed, a furniture, one sabel horse and hunting saddle and bridle three cows and pigs one hundred harness one cotton wheel and cards and all my cooking tools and ten pounds worth of work to be done by Burrell Johnston and Arthur Johnston on this plantation
- Item I give unto the child that my wife is now big with the land, that I give live on receiving the use of it to my life till the child comes of age and if the Legatee decrease then the Legatee is returned to the other children before said, land. I lend one negro woman to my loving wife for the term of ten years and after the term of ten years she and her increase from this time to be sold to the highest bidder for six months credit. The money to be equally divided between Stephen Spell, Demary Spell, Reddick Spell, the sons of Judith Spell, and all the residue of

my estate not particular mention after my just debts are payed, if any to be divided among the whole boys. I hereby constitute my worthy friend Joseph Spell executor to my last will and testament -
