State of North Carolina Johnston County. In the name of God I Thomas Barrow am in proper health thanks be to God and calling to mind the mortality of my body knowing that it is appointed for all men once to die do make and ordain this my last will and testament that is to say first of all I give my soul into the hands of God that gave it and my body to be buried in a decent manner at the discretion of my executor and as touching my worldly estate wherein God has blessed me with in this life I give and dispose and devise of in manner and form as follows. First of all I lend to my beloved wife Winnie Barrow the whole of my estate during her natural life or widowhood.

Item I give one feather bed to my daughter Emily Hayles.

Item I give to my grand son Lewis Hayles all my land and all my household goods and chattles all my stocks of all kinds and every other thing that I am possessed with. Also I make and ordain Lewis Hayles and Simon Barnes to be my only and sole executors of this my last will and testament and I do utterly and disannull all and every other will and testament or bequest by me bequeathed ratified and confirmed this and no other to be my last will and testament in witness whereof I have hereunto set my hand and seal this the 30th day of September 1803. Will of John Green

In the name of God Amen I John Green of Johnston County being of perfect mind and memory thanks be to God do therefore this fourteenth day of December one thousand eight hundred and nine make and ordain this my last will and testament in manner and form as follows that is to say

Item I give to my wife Welthy Green the whole of my plantation where I now live during her life one feather bed and furniture and bedstead I leave to my wife Welthy Green one horse by the name of Buck I leave to my wife also one jolly named Penny. I leave to my wife also I leave three cows and yearlings and two wheels one wollen wheel and one linen wheel one cotton pair of cards and one pair of wollen cards I give unto my wife Welthy Green one pot I give to my wife also one side saddle and bridle three cows and pigs one table six chairs five earthen plates all the cotton and flax a case of knives and forks one safe frying pan and griddle two axes two weeding hoes one grubbing hoe two flesh hoes one loom and set of flax coms what is above written I give unto my wife Welthy Green during her life

Item I give and bequeath unto my son Nathan Green one mare named Pleasure bridle and saddle also one shot gun I give to my son Nathan Green.

Item I give and bequeath unto my daughter Sarah Green one bed bedstead and furniture one dish one basin two plates.

Item I give unto my daughter Elizabeth Green one bed bedstead and furniture one dish one basin and two plates.

Item I give and bequeath unto my daughter Lamy Green one bed, bedstead and furniture one dish two basin two plates.

Item I give and bequeath unto my son Wiley Green one colt bridle and saddle.

Item I give and bequeath unto my son Jacky Green ten dollars to come out of my estate.

Item I give and bequeath unto my son William Green one feather bed and furniture one horse named Jolly and sundry other

the rest of the money to be equally divided between
seven children. I do hereby constitute and appoint George
W. W. Richardman Jr executor to this my will and
testament in witness hereof I the said John Green hath
hereunto set my hand and seal this day and year first abo

Will of Lewis Grice

In the name of God Amen I Lewis Grice of the State of
North Carolina, and Johnston County being in a low state of
health but of sound and perfect mind and memory thanks be
unto God, for the same and calling to mind the mortality
of the body and knowing that it is appointed for all men
once to die do the 4th day of February in the year of our
Lord one thousand eight hundred and nine make and publish
this my last will and testament in manner following that is
to say

- First I give and bequeath unto my beloved brother Theophilus Grice
my right to the negroes that he has in possession then was
the property of William Grice deceased and ten pounds in cash
to be raised out of my estate to him and his heirs forever.
- Item I give and bequeath to my beloved brother Jacob Grice ten
head of cattle that he has in possession and five head of sheep
and twenty five silver dollars ten head of year old hogs to him
and his heirs forever.
- Item I give and bequeath to my beloved brother Alexander Grice
one hundred silver dollars to him and his heirs forever.
- Item I give and bequeath to my beloved brother Stephen Grice ten
negroes (to wit) Abe, Jack, Dollit, Habel, Tom, Ben, Simon, Andy
and Pastence and Brady and six hundred and seventy acres of land
it being the whole of the land I possess including the plantation
where I now live to him and his heirs forever.
- Item I give and bequeath to my beloved sister Delida Watkins
one hundred silver dollars to be raised out of my estate to
her and her heirs forever.
- Item I give and bequeath to my brother Stephen Grice my
brandy still and all my stock of horses and cattle, sheep
that is not before mentioned and all the household and
kitchen furniture and all my corn and bacon and all my
farming tools and all species of property of whatsoever
nature or named it may be that is my property to him
and his heirs forever and I do hereby make and ordain my
loving brother Stephen Grice and Jonathan Plimant and
