Item I give and bequeath to my well beloved daughter Elizabeth two hundred and fifty acres of land on south side of the south prong of North Creek joining lands of North Bafoot line and one feather bed and furniture are chest to her and her heirs and assigns forever.

Item I give and bequeath to my well beloved daughter Mary one hundred and fifty silver dollars one feather bed and furniture and one chest to her and her heirs and assigns forever.

Item I give and bequeath to my sons Nehemiah and Eden one gun to each and fifteen pounds each to them and their heirs forever and further more my will is that my copper still and blacksmith tools should be sold by my executor giving twelve months credit and the money arising there from and the collection of all the debts due me after taking out Marys one hundred and fifty dollars and the two boys Nehemiah and Eden fifteen pounds to each the rest to be equally divided among the children and further more I do make constitute appoint establish and ordain my trusty friend Samuel Lee for my executor of this my last will and testament in witness whereof I the said Bazilla Blackman in bath hereto set my hand and seal the day and date first above written. Will of Jonathan Walton

In the name of God Amen I Jonathan Walton in the County of Johnston and State of North Carolina, do make ordain and declare this instrument which is written with my own hand to be my last will and testament revoking all others first all my just debts I wish to be punctually and speedily paid and the legacies herein after bequeathed are to be discharged as soon as circumstances will permit and in the manner directed

Item To my friend Joseph Richardson I give one hundred dollars provided he will serve as my executor to this my last will and for the trouble and expense he will be at in settling my estate

Item I give Christian Jordan (my sister) one hundred dollars.

Item I give to my sister Sarah Pottaway one hundred dollars.

Item I give to my brothers Thomas and James Walton one hundred pounds to each of them that is four hundred dollars to be payed out in education of them I also give to James my brother one hundred and fifty pounds or three hundred dollars to make up his share equal to the others in division of our fathers estate wherein he had not as I thought and equal with the other heirs. I give to my brother William Walton fifty dollars I wish my horses, cattle hogs household and kitchen furniture to be sold on a credit of twelve months also the goods I now have on hand I wish sold on a credit of twelve months. My land I wish not to be sold nor my lots in the town of Smithfield until my brother James Walton arrive to the age of twenty one years then I wish all my lands to be sold and the money equally divided between all my brothers, John, William, Thomas and James Walton after paying all the legacies as above directed I wish all the money or property left to be equally divided between my brothers John, William, Thomas and James Walton also I wish negro wench Tamer to be sold on a credit of one year and the money equally divided between my brothers John, William, Thomas and James Walton after paying the legacies as before directed I wish each heirs part be paid as they arrive at the age of twenty one years that is let them receive their part of what is then in hand. If any one of them should die before he attains to the age of twenty one years it is my wish that the other brothers and not the sisters herein named

should have the property. I don't wish that any other person but those herein before named that is John, William, Thomas and James Waller should have any of my property that is left after paying all the legacies as before mentioned. In witness of all and each of the things herein contained I have set my hand and seal and I do appoint my dearly beloved friend Joseph Richardson Esq. my executor this 8th day of September in the year of our Lord one thousand eight hundred and four.

Will of Matthew Wilder

In the name of God Amen I Matthew Wilder Jr of the State of North Carolina and Johnston County do constitute this my last will and testament and devise it my be received by all as such and I do humbly commit my soul to God who gave it as to my worldly estate which it hath pleased God to give me I give and bequeath in manner and form following.

Item I give and bequeath to my daughter Elizabeth Wilder upon her given a lawful receipt to my lawful heirs for the money given to her by — by Elizabeth Lee her grandmother one negro girl named Rose and one feather bed and furniture and sixteen silver dollars to her and her heirs forever.

Item I give and bequeath to my daughter Nancy Wilder to her and her heirs forever one negro girl named Hannah and one feather bed and furniture sixteen silver dollars.

Item I give and bequeath to my daughter Catharine Wilder to her and her heirs forever one negro girl named Jane and one feather bed and furniture and sixteen silver dollars.

Item I give and bequeath to my daughter Jane Wilder to her and her heirs forever one negro girl named Mary and one feather bed and furniture and sixteen silver dollars. and my will and desire is that my wife Catharine Wilder have the whole and sole care of my three daughters (to wit) Nancy, Catharine and Jane Wilder and all the estate during her lifetime or widowhood or untill they shall arrive to the age of twenty one years but if either of three do marry before they do arrive to the age of twenty one my will is that they shall have their property at the time of their marriage.

Item I give and bequeath to my son William Wilder to him and his heirs forever at the end of my wife's widowhood four hundred and thirty acres of land more or less whereon I now live with all improvements thereon and if my son William Wilder dies without a lawful heir or before he comes to the age of twenty one years my will is that my son Matthew Wilder shall have the land given to him.
