

Will of Joseph Richardson

In the name of God Amen I Joseph Richardson of the County of Johnston and state of North Carolina being in bad health but of sound mind and memory do make and ordain this my last will and testament in manner and form following To wit I give and devise to my son Pharaoh Richardson all my land lying on the north side of Little River except ten acres adjoing my mills also all the negroes now in his possession to him and his heirs &c.

Secondly I give and devise to my son Lunceford Richardson all the land lying on the south side of said Little River with my mills and ten and the ten acres thereto adjoining with all the negroes that is in his possession also my negro man by name of Russell to him and his heirs & c.

Thirdly I give and devise to my beloved daughter Hally Hardly my negro woman Hally and her husband Sam and her three last children to my wife Winfield, Willis and Sam to her and her heirs &c

Fourthly My will and devise is and so devise it that the residue of my negroes except my boy Dugum be equally divided between my two sons and daughters above mentioned.

Fifthly I give and devise to David R. Pender now living in South Carolina my negro boy Dugum and three hundred dollars in money provided he is living at the time of my death.

Sixthly My will and devise is that all the residue of my estate be sold and after the payment of all my just debts with the legacy given in money then the balance if any be equally divided among my three children named above mentioned.

Seventhly And lastly I appoint my two sons Pharaoh Richardson and Lunceford Richardson my executors to this my last will & testament in witness whereof I have hereunto set my hand and seal this the 1st day of May 1838

I give and bequeath unto my beloved daughter Mary Steinant one boon and all the gear belonging to said boon to her and her heirs forever after defraining the expense of my estate.

I give unto my four daughters namely Elizabeth, Mary, Ann & Martha Steinant all my crop of corn and fodder all my cattle and hogs all my sheep all my household and kitchen furniture all my plantation utensils of all kinds to them & their heirs forever All my property not before mentioned I leave to my four daughters namely Elizabeth, Mary, Ann & Martha Steinant to them and their heirs forever. And I do hereby nominate and appoint my truly and well beloved friend Hardy Steinant my executor.

I give and devise to David R. Pender now living in South Carolina my negro boy Dugum and three hundred dollars in money provided he is living at the time of my death.

Sixthly
My will and devise is that all the residue of my estate be sold and after the payment of all my just debts with the legacy given in money then the balance if any be equally divided among my three children named above mentioned.

Seventhly
