

## Will of Mary Frellick

Mary Frellick of the County of Johnston being of sound and perfect mind and memory do this twentieth day of August in the year of our thousand eight hundred and twenty eight make and publish this my last will and testament in the manner following that is to say

I give to Jane Frellick my daughter the negro girl Lany also one bed and furniture for it complete, also to my grand daughter Mary Elizabeth Frellick seventy five dollars for the purpose of purchasing a watch when she may arrive at and age to wear one, also one bed and furniture complete and to my grand child Joseph Osborn Frellick the sum of seventy five dollars for the purpose of buying a watch when he shall attain and age that his father may think fit for him to wear one the residue of my property I divide equally between my two children James and Jane Frellick a note of one thousand seven hundred and twenty five dollars is a balance due me from James Frellick and I exonerate him from all claims to Mathews lands considering the amount paid me by him in said note and a negro girl (for which he paid) as a fair portion of the lands in as much as he has paid all the expenses attending the law suit at the North.

And I hereby make and ordain my son James Frellick executor of this my last will and testament for witnesses whereof the said Mary Frellick have to this my last will and testament set my hand and seal the day and date above written

## Will of Patience Parker.

In the name of God Amen, I being weak in body but in a sound and perfect mind calling to my recollection that all humane has to die - this being my last will and testament

Item I give my soul to God who gave it, my body to the dust from which it came =

Item I give and bequeath unto my beloved daughter Emily all my hogs, and one feather bed and all my kitchen furniture.

Item I give and bequeath unto my beloved son Powell one feather bed.

Item I give and bequeath unto my son Needham one feather bed.

Item I give and bequeath unto my beloved children (viz) Emily, Powell and Needham my bed clothing and furniture and all the residue of my property except my wearing clothes to be equally divided between my four youngest children (viz) Patience, Needham, Powell and Emily.

I give all my wearing clothes of every description to be equally divided between my three daughters (to wit) Edith, Patience and Emily. I hereby make and ordain this my last will and testament and appoint my son Powell Parker my executor this the 24<sup>th</sup> day of April 1828. I hereunto set my hand and seal
