Carrell and James jointly all and singular ^{my} lands and tenements
and appertinances whatsoever thereunto belonging together with
all the residue of my personal property by them fully to be
possessed and enjoyed.

I also I likewise constitute and make the said William
Carrell the sole executor of this my last-will and testa-
ment.

And I do hereby utterly disallow revoke all and every former
testaments wills legacies and executors &c by me in anywise
before named and willed, ratifying and confirming this to be
my last-will and testament.

eighteen hundred and nine

Will of Moses Oreal
State of North Carolina, Johnston County.

In the name of God Amen, I Moses Oreal not being in
in perfect health but sound in mind and memory calling
to mind the mortality of my body and knowing that it
is appointed for all men once to die I do make and
ordain this to be my last will and testament that is to
say first of all

I give my soul into the hands of God who gave it
and my body to be buried in a decent manner at the
discretion of my executors and as touching my worldly estate
wherein God hath blessed my with in this life I give
and devise and dispose in manner and form as follows

First of all I lend to my beloved wife Nancy Oreal
one negro fellow by the name of Angus one negro
woman by the name of Peg one bay mare one cart
mare two cows and calves nine head of sheep and fif-
teen head of hogs one grubbing hoe two weeding hoes two
cutting axes one cart and the gear one hundred and
fifty acres of land including the houses or it two
woolen wheels and cards one flax wheel one feather bed and
furniture two pots five pewter dishes and twelve pewter
plates four earthen plates three pewter basins one chest
one case of knives and forks six chair frames two tubs
two pails one hunting saddle one pan one skillet one
mans saddle two plows and gear during her natural life
a widowhood and after her decease to come into my
estate again and to be sold and equally divided between
William Oreal, Willy Oreal, John Oreal, Obedience Oreal and
Nancy Oreal all but the land that I leave to my
son Willy Oreal.

Item I give to my daughter Martha Johnston forty shillings
and to each of her children begotten of her body forty
shillings a piece.

Item I give to my daughter Obedience Oreal one feather bed
and furniture and two cows and calves and the child
the the negro woman by the name of Peg is big with
and if she boxes it the next one she brings to good.

Item I give to my daughter Nancy Oreal one feather bed
and furniture two cows and calves and one negro girl
by the name of Charlotte

- Item I give to my son Willey Oneal one feather bed and furniture and two cows and calves one negro boy by the name of Thomas one hundred and fifty acres of land after the decease of his mother and one hundred acres of land on little Buffalo.
- Item I give to my son William Oneal one negro boy by the name of Willis and one cow and calf.
- Item I give to my son Ison Oneal two hundred dollars in money out of my estate.

I also make and ordain my son William Oneal and my son Willey Oneal to be my only and sole executors of this my last will and testament and do utterly and disannull all and every other will and testament or legacies by me bequeathed satisfying and confirming this and no other to be my last will and testament, in witness whereof I have hereunto set my hand and seal this the 17th day of December 1812

Will of Dempsey Perry

In the name of God Amen, I Dempsey Perry of Johnston Co in the State of North Carolina, being through the abundant mercy and goodness of God, this weak in body yet of an sound and perfect understanding and memory do make and constitute this instrument of writing my last will and testament in manner and form following

I lend to my wife Elizabeth Perry this house wherein I now dwell with all my lands for and during the term of her life a widowhood.

Impression

- Item I give to my sons Reubin, John and William all my carpenters and roofers tools to be equally divided between them
- Item I give to my son John Perry one shot gun and one case of bottles
- Item I give to my son William Perry one shot gun and one case of bottles. The remainder of my personal estate I give to my said wife and my sons Reubin, John and William and my four daughters, Mary, Sarah, Elizabeth and Winney.
- To be equally divided amongst them except my son Reubin who is to have an equal share with what I gave him before of making of this will which was one mare one shot gun one feather bed and furniture and one cow and lamb.

Item

I give and bequeath to my son John Perry and his heirs forever all my lands lying on the east side of Hinton's Creek including the house wherein I now dwell after the marriage or death of my wife

Item

I give and bequeath to my son William Perry and his heirs forever all my land lying on the west side of said Hinton's Creek including the fork of of said creek and constitute and appoint my wife executrix and my son Reubin Perry executor of this my last will and testament. In witness whereof I have hereunto set my hand and seal this eleventh day of February 1796. Signed sealed and acknowledge in presence of us
