I give and bequeath unto my loving children as follows Wiliam Gate, Francis Harrell, Jacob Harrell, Lary Harrell William Harrell all the above mentioned the sum of five shilling a piece then the residue of my whole estate I give and bequeath unto my son Azay Harrell to his proper use and benefit himself. This heirs and assigns forever in witness I the said Sarah Harrell have hereunto set my hand and seal this the 10th day of October eight hundred and seven. signed, sealed and delivered by the testator in her lifetime to be her last will and testament in presence of

Impius I give and bequeath unto my brother Turner Smith after paying all my just debts, lawful debts all and singular my lands and tenements with my half of the mill built by myself and Aaron Smith after he clears the same of all the incumbrance now on it and likewise all my stock horses cattle &c and all my other goods and chattles of every kind whatsoever reserving unto reserving unto my sister Patience Aoyt the sum of twenty five dollars and to Aaron Smith my brother twenty dollars and to my brother Alexander Smith fifty dollars and to my mother twenty five dollars if living after my decease all the levied out of my estate and I do hereby appoint my brother Turner Smith and Daniel Aoyt executors to this my last will and testament hereby revoking disannulling and making void all former wills and bequeaths by me made declaring this and only this to be my last will and testament in witness whereof I have hereunto set my hand and seal this 4 day of March in the year of our Lord one thousand eight hundred and five.

Impius I give and bequeath unto my brother Turner Smith after paying all my just debts, lawful debts all and singular my lands and tenements with my half of the mill built by myself and Aaron Smith after he clears the same of all the incumbrance now on it and likewise all my stock horses cattle &c and all my other goods and chattles of every kind whatsoever reserving unto reserving unto my sister Patience Aoyt the sum of twenty five dollars and to Aaron Smith my brother twenty dollars and to my brother Alexander Smith fifty dollars and to my mother twenty five dollars if living after my decease all the levied out of my estate and I do hereby appoint my brother Turner Smith and Daniel Aoyt executors to this my last will and testament hereby revoking disannulling and making void all former wills and bequeaths by me made declaring this and only this to be my last will and testament in witness whereof I have hereunto set my hand and seal this 4 day of March in the year of our Lord one thousand eight hundred and five.
