

Will of Willis Cole

In the name of God Amen I Willis Cole of Johnston County in the state of North Carolina being weak in body though of sound and perfect mind and memory blessed be God do this 26<sup>th</sup> day of September in the year of our Lord one thousand eight hundred and twenty three make and publish this my last will and testament in manner and form following that is to say Item First I lend to my beloved wife Sarah Cole two hundred acres of land including the plantation and buildings wherein I now live also fifty four more acres more that patten in my name for and during her natural life.

Item Second I lend unto my beloved wife Sarah Cole no still one barrel of brandy and all my cider cask three feather beds five cows and calves two mares and one colt three sows and pigs twenty five year old hogs sixty bushel corn three blades stacks and three top stacks of fodder her choice ten head of sheep her choice one weaving loom and gear one cart and wheels two wooden wheels and one linen wheel all the pewter and crockery ware and knives and forks all the pots and hangers dutch head trays and bowls two flukes hoes and two cultivator ploughs and frames two pairs two year two chest one table and all sitting chairs all the tabs nail and piggins and all the working tools one pair of flat irons, fire tongs and shovel all the popotates and cotton one bofat fifteen geese for and during her natural life.

Item Third My will and desire is that all the rest of my land not lent to my wife be sold at a credit of twelve months also all the rest of my perishable property to lent to my wife to be sold at a six month credit and the money arising therefrom (the sale) after paying all my just debts be equally divided amongst my children.

Item Fourth My will and desire is that the lands and other property lent to my wife after her decease be sold and the money arising from the sale thereof be equally divided amongst my children I do hereby make and ordain my friend Henry Stevens & Nicolas Rose executors of this my last will and testament in witness whereof I the said Willis Cole have seal the day and date above written

Item Fourth I give and bequeath unto my beloved daughter Edy Futchell five dollars to be paid in money.

Item Fifth I give and bequeath to my beloved son Gibson Gerald all my lands my negro woman named Dina and her increase my stock of all kind my esof household and kitchen furniture riot heretofore mentioned farming utensils & blacksmith tools

I also lend to my beloved son Gibson Gerald one negro man named Isaac one negro boy named Jack during his natural life and after his death to be sold and the money arising from the sale of said negro to the heirs lawfully begotten by his body.

I leave one negro man named Wright one boy named Curtis one girl named Hulfin one negro girl Chilly and one negro boy slender am to be sold after my death and after paying all and lawful debts out of the money arising from the sale of said negro the balance if any I give and bequeath to my beloved son Gibson Gerald and his heirs forever also all my property not herein mentioned I leave to be sold after my death and after paying all my just and lawful the money to my beloved son Gibson Gerald and his heirs lawfully begotten by his body forever.

I leave to Piety Godwin one feather bed without furniture And I hereby make and ordain my worthy friend Gibson Gerald, John Raines Jr and Oliver Raines executors of this my last will and testament in witness whereof I the said John Gerald have to this my last will & testament set my hand and seal the day and year above written
